How the installers work

You must use the suite installer and the product installer when you install or upgrade any IBM® Marketing Software product. For example, for installing Campaign, you must use the IBM Marketing Software suite installer and the IBM Campaign installer.

Make sure that you use the following guidelines before you use the IBM Marketing Software suite installer and the product installer:

- The suite installer and the product installer must be in the same directory on the computer where you want to install the product. When multiple versions of a product installer are present in the directory with the master installer, the master installer always shows the latest version of the product on the IBM Marketing Software Products screen in the installation wizard.
- If you are planning to install a patch immediately after you install an IBM Marketing Software product, make sure that the patch installer is in the same directory as that of the suite and product installers.
- The default top-level directory for IBM Marketing Software installations is /IBM/IMS for UNIX or C:\IBM\IMS for Windows. However, you can change the directory during installation.

Modes of installation

The IBM Marketing Software suite installer can run in one of the following modes: GUI mode, console mode, or silent mode (also called the unattended mode). Select a mode that suits your requirements when you install Campaign.

For upgrades, you use the installer to perform many of the same tasks that you perform during the initial installation.

GUI mode

Use the GUI mode for Windows or the X Window System mode for UNIX to install Campaign by using the graphical user interface.

Console mode

Use the console mode to install Campaign by using the command line window.

Note: To display the Installer screens correctly in console mode, configure your terminal software to support UTF-8 character encoding. Other character encoding, such as ANSI, will not render the text correctly, and some information will not be readable.

Silent mode

Use the silent or unattended mode to install Campaign multiple times. The silent mode uses response files for installation, and does not require user input during the installation process.

Note: Silent mode is not supported for upgrade installations in clustered web application or clustered listener environments.

Integration of Campaign with eMessage

When IBM Campaign is integrated with IBM eMessage, you can use eMessage to conduct highly personalized email marketing campaigns. eMessage provides access to the resources that are hosted by IBM. With eMessage you can design, send, and individually monitor customized messages that are based on the information that is stored in your customer data mart.

In Campaign, use flowcharts to create lists of email recipients and select personalization data for each recipient.

In eMessage, use email design, transmission, and delivery resources that are hosted by IBM to conduct email marketing campaigns.

When you install IBM Campaign, the installer automatically includes the files that are required to support IBM eMessage. The following actions are completed for eMessage:

- eMessage is created as a sub-directory in the Campaign directory structure.
- eMessage configuration properties are listed in the IBM Marketing Platform, but the properties are not active.
- eMessage-specific database tables are created in the Campaign schema. However, the database tables contain only initial data.

 Menus and other features that are specific to eMessage do not appear until you enable and configure eMessage.

Before you can send personalized marketing email, you must request a hosted email account from IBM.

When you request an email account, IBM begins a consultation process to familiarize you with eMessage, connect you to hosted email resources, and establish your reputation as a legitimate email marketer among leading Internet Service Providers (ISPs). Establishing a favorable reputation is critical to successfully delivering your marketing message to your customers and prospects.

For more information about how to enable and configure eMessage and prepare your hosted email account, see the *IBM eMessage Startup and Administrator's Guide*.

eMessage components

eMessage requires specialized components called the Recipient List Uploader (RLU) and the Response and Contact Tracker (RCT).

The RLU is a eMessage plugin component that operates with Campaign to upload addresses, personalization data, and metadata that is associated with a list of email recipients to IBM Marketing Software Hosted Services.

The eMessage RCT retrieves link tracking and email delivery notification data from IBM Marketing Software Hosted Services, and stores the data in the eMessage system tables that reside in the Campaign schema.

The eMessage components operate when you enable and configure IBM eMessage. For more information about enabling eMessage and working with the RLU and RCT, see the *IBM eMessage Startup and Administrator's Guide*.

Default component installation locations

The IBM installer places the RLU on the computer where you installed the Campaign J2EE application. The RLU location is recorded in the Campaign > partitions > partition1 > eMessage > eMessagePluginJarFile configuration property.

The installer places the RCT on the computer where you installed the Campaign server.

If the J2EE and server components are on separate computers, run the installer on each machine to install the RLU with the J2EE application and the RCT with the Campaign server.

eMessage components in multiple partitions

One RLU exists for the entire eMessage installation. The installer populates the eMessagePluginJarFile configuration property only for the default partition. If you are using multiple partitions in your eMessage installation, you must manually configure the location of the RLU for all other partitions. The location specified in the eMessagePluginJarFile property is the same for all partitions. For more information, see "Specifying the Recipient List Uploader location for eMessage" on page 85.

Only one RCT exists for the entire eMessage installation. eMessage does not need to specify the location of the RCT in a configuration property. Responses that are received by the RCT automatically specify the appropriate local partition for correct response attribution.

Chapter 2. Planning the Campaign installation

When you plan your Campaign installation, you must ensure that you have set up your system correctly, and that you have configured your environment to deal with any failures.

Prerequisites

Before you install or upgrade any IBM Marketing Software product, you must ensure that your computer complies with all of the prerequisite software and hardware.

System requirements

For information about system requirements, see the *Recommended Software Environments and Minimum System Requirements* guide.

In order for Opportunity Detect to connect to the DB2 database, the DB2 installation must include the install header files in the /home/db2inst1/include directory on client machine. To include the header files in the installation, select the **Custom Install** option when you install DB2 and select the **Base Application Development Tools** feature.

DB2 requirements

In order for Opportunity Detect to connect to the DB2 database, the DB2 installation must include the install header files in the home/db2inst1/include directory on client machine. To include the header files in the installation, select the **Custom Install** option when you install DB2 and select the **Base Application Development Tools** feature.

Network domain requirements

The IBM Marketing Software products that are installed as a suite must be installed on the same network domain to comply with the browser restrictions that are designed to limit the security risks that can occur with cross-site scripting.

JVM requirements

IBM Marketing Software applications within a suite must be deployed on a dedicated Java[™] virtual machine (JVM). IBM Marketing Software products customize the JVM that is used by the web application server. If you encounter errors that are related to the JVM, you must create an Oracle WebLogic or WebSphere[®] domain that is dedicated to the IBM Marketing Software products.

Knowledge requirements

To install IBM Marketing Software products, you must have a thorough knowledge of the environment in which the products are installed. This knowledge includes knowledge about operating systems, databases, and web application servers.

Access permissions

Verify that you have the following network permissions to complete the installation tasks:

- Administration access for all necessary databases
- Read and write access to the relevant directory and subdirectories for the operating system account that you use to run the web application server and IBM Marketing Software components
- · Write permission for all files that you must edit
- Write permission for all directories where you must save a file, such as the installation directory and backup directory if you are upgrading
- · Appropriate read, write, and execute permissions to run the installer

Verify that you have the administrative password for your web application server.

The following additional permissions are necessary for UNIX:

- The user account that installs Campaign and Marketing Platform must be a member of the same group as the Campaign users. This user account must have a valid home directory, and have write permissions for that directory.
- All installer files for IBM products must have full permissions, for example, rwxr-xr-x.

JAVA HOME environment variable

If a **JAVA_HOME** environment variable is defined on the computer where you install an IBM Marketing Software product, verify that the variable points to a supported version of JRE. For information about system requirements, see the *IBM Marketing Software Recommended Software Environments and Minimum System Requirements* guide.

If the JAVA_HOME environment variable points to an incorrect JRE, you must clear the JAVA_HOME variable before you run the IBM Marketing Software installers.

You can clear the <code>JAVA_HOME</code> environment variable by using one of the following methods:

- Windows: In a command window, enter **set JAVA_HOME=** (leave empty) and press **Enter**.
- UNIX: In the terminal, enter **export JAVA_HOME=**(leave empty) and press **Enter**.

The IBM Marketing Software installer installs a JRE in the top-level directory for the IBM Marketing Software installation. Individual IBM Marketing Software application installers do not install a JRE. Instead, they point to the location of the JRE that is installed by the IBM Marketing Software installer. You can reset the environment variable after all installations are complete.

For more information about the supported JRE, see the *IBM Marketing Software Recommended Software Environments and Minimum System Requirements* guide.

Marketing Platform requirement

You must install or upgrade Marketing Platform before you install or upgrade any IBM Marketing Software products. For each group of products that work together, you must install or upgrade Marketing Platform only once. Each product installer checks whether the required products are installed. If your product or version is

not registered with Marketing Platform, a message prompts you to install or upgrade Marketing Platform before you proceed with your installation. Marketing Platform must be deployed and running before you can set any properties on the **Settings** > **Configuration** page.

IBM SPSS Modeler Advantage Enterprise Marketing Management **Edition replaces PredictiveInsight**

If you previously used IBM PredictiveInsight, you can no longer use the legacy Model and Score process boxes in IBM Campaign.

After you install IBM Campaign version 9.1.0 or later, the legacy Model and Score process boxes are unconfigured in existing flowcharts. You must manually re-create the predictive models either by using IBM SPSS® Modeler Advantage Enterprise Marketing Management Edition or by using the SPSS Model process box.

Note: Legacy Model and Score process boxes are inactive and cannot be run. However, they can be viewed for configuration details.

For more information, see the IBM Campaign and IBM SPSS Modeler Advantage Enterprise Marketing Management Edition Integration Guide.

Campaign installation worksheet

Use the Campaign installation worksheet to gather information about the Campaign database and about other IBM Marketing Software products that are required for the installation of Campaign.

Use the following table to gather information about the empty database that was created for the IBM Campaign system tables. The empty database that you set up for IBM Campaign can have any name. If you use UA SYSTEM TABLES as the ODBC name for that database, the IBM Campaign system tables will be mapped automatically.

You can use the information in Table 3 when you edit the setenv.sh file during the installation and configuration process.

Checklist for IBM Marketing Platform database

The installation wizards for each IBM Marketing Software product must be able to communicate with the Marketing Platform system table database to register the product. Each time that you run the installer, you must enter the following database connection information for the Marketing Platform system table database:

- IDBC connection URL
- · Database host name
- Database port
- · Database name or schema ID
- User name and password for the database account

Checklist for IBM Marketing Platform deployment on the web application server

Obtain the following information before deploying Marketing Platform:

- Protocol: HTTP, or HTTPS if SSL is implemented in the web application server.
- Host: The name of the machine on which the Marketing Platform will be deployed.
- Port: The port on which the web application server listens.
- Domain name: The company domain of each machine where IBM products are installed. For example, example.com. All IBM products must be installed in the same company domain, and you must enter the domain name in all lower case letters.

If there is a mismatch in domain name entries, you might encounter problems when you attempt to use Marketing Platform features or navigate among products. You can change the domain name after the products are deployed by logging in and changing values of the relevant configuration properties in the product navigation categories on the **Settings > Configuration** page.

Checklist for enabling Marketing Platform utilities

If you plan to use the Marketing Platform utilities, obtain the following JDBC connection information before you start to install the Marketing Platform.

• Path to the JRE. The default value is the path to the 1.8 version of the JRE that the installer places under your IBM installation directory.

You can accept this default or specify a different path. If you specify a different path, you must point to the 1.8 version of the Sun JRE.

- JDBC driver class. The installer automatically provides this, based on the database type that you specify in the installer.
- JDBC connection URL. The installer provides the basic syntax, including the host name, database name, and port. You can customize the URL by adding additional parameters.
- JDBC driver classpath on your system.

Information about the web component

Obtain the following information for all IBM Marketing Software products that have a web component, which you deploy on a web application server:

- The name of the systems on which the web application servers are installed. You can have one or several web application servers, depending on the IBM Marketing Software environment that you are setting up.
- The port on which the application server listens. If you plan to implement SSL, obtain the SSL port.
- The network domain for your deployment system. For example, mycompany.com.

IBM Site ID

If you are installing an IBM Marketing Software product in one of the countries listed on the Country for Install screen of your product installer, you must enter your IBM Site ID in the space provided. Your IBM Site ID can be found on one of the following documents:

- IBM Welcome letter
- Tech Support Welcome letter
- · Proof of Entitlement letter
- Other communications that are sent when you purchase your software

IBM might use the data that is provided by the installed software to better understand how customers use our products and to improve customer support. The data that is gathered does not include any information that identifies individuals. Complete the following actions if you do not want to have such information to be collected:

- 1. After Marketing Platform is installed, log on to Marketing Platform as a user with administration privileges.
- 2. Go to **Settings > Configuration**, and set the **Disable Page Tagging** property under the **Platform** category to True.

Installation order for IBM Marketing Software products

When you install or upgrade multiple IBM Marketing Software products, you must install them in a specific order.

Planning failover configuration of Campaign

When you install Campaign, you can configure your environment to address any failures of the web application server (front-end) or listener server (back-end).

Definition of terms

Required component	Installation option	Definition
Campaign web application server (front end)	J2EE Application	The web application that provides the Campaign user interface.
Campaign listener server, sometimes called analytic server (back end)	Campaign Server	The startup scripts and components that support the design and execution of flowcharts.

Campaign web application server clustering

You can deploy the Campaign web application server in a clustered environment to support load balancing.

Before you begin the installation, be sure to read Chapter 12, "IBM Campaign web application clustering," on page 107.

Campaign listener server clustering

Listener (analytic) server clustering, also referred to as back-end clustering, involves the use of multiple listeners for the purpose of high availability and load balancing. Listener clustering is important because flowchart runs happen at the back end.

Before you begin the installation, be sure to read Chapter 13, "Installing a clustered listener environment," on page 113.

Chapter 3. Preparing data sources for Campaign

Campaign uses data sources to store user and interaction data.

Note: Information about using web application clustering in IBM Campaign is provided in Chapter 12, "IBM Campaign web application clustering," on page 107.

Complete the following steps to prepare data sources for Campaign.

1. Create a database or a database schema for the Campaign system tables. The empty database that you set up for IBM Campaign can have any name.

Note: Campaign requires customer tables, which should already exist.

- 2. Create a database user account.
 - The database user account must have the following rights: CREATE, DELETE, DROP, INSERT, SELECT, and UPDATE.
- 3. Create ODBC or native connections. If you use UA_SYSTEM_TABLES as the ODBC name for that database, the IBM Campaign system tables will be mapped automatically.
- 4. Configure the web application server for your JDBC driver.
- 5. Create JDBC data sources in the web application server.

Creating database or schema for Campaign system tables

The IBM Campaign system tables hold application data. The empty database that you set up for the system tables can have any name. To ensure that the system tables will be mapped automatically, the ODBC name for that database must be UA_SYSTEM_TABLES. If you have multiple partitions, create data sources for each partition where you want to enable IBM Campaign.

Complete the following steps to create a database or database schema for Campaign system tables:

1. Create a system user account for later in the installation process.

Note: The system user account must have the following rights: CREATE, DELETE, DROP, INSERT, SELECT, and UPDATE.

2. Print the "Campaign installation worksheet" on page 9. Obtain the information about your database or schema and database account, and then note this information in the checklist. Continue to fill in the checklist as you perform the rest of the steps in this section, so that you can use this information later in the installation process.

Note: The IBM eMessage system tables are created in the Campaign schema during the installation. However, eMessage is not enabled.

Creating ODBC or native connections

Create ODBC or native connections so that the Campaign server can access the Campaign database. Create ODBC or native connections on the computer where you installed the Campaign server.

The computer on which the Campaign server is installed must have an ODBC or native connection to the following databases:

- The database or schema that contains the Campaign system tables
- The database or schema that contains the customer tables (sometimes called user tables).

Note: If you are configuring just one partition, name the data source UA_SYSTEM_TABLES. If you are configuring more than one partition, do not name any of the data sources UA_SYSTEM_TABLES. For more information, refer Configuring multiple partitions for Campaign.

Use the following guidelines to create these ODBC or native connections:

- For databases on UNIX: Create native connections for DB2 and Oracle databases or ODBC connections for other databases, such as SQL Server, Teradata, Netezza[®]. The procedure for creating a native data source differs depending on the data source type and the version of UNIX. See the data source and operating system documentation for specific ODBC driver installation and configuration instructions.
- For databases on Windows: Create a new ODBC connection in the Control Panel Administrative Tools > Data Sources (ODBC) section.
- For DB2 databases on z/OS[®]: The database user account must have SYSADM privileges. The DBADM privilege is not sufficient because it does not provide access to all of the required system objects. Without SYSADM privileges, flowcharts might not run successfully.

Note: Campaign supports certain versions of DB2 on z/OS for customer tables only, not system tables. For more information, see the *Recommended Software Environments and Minimum System Requirements*.

Be sure to record the ODBC name in the "Campaign installation worksheet" on page 9.

Configuring the web application server for your JDBC driver

The web application server where you plan to deploy Campaign must contain the correct JAR file to support JDBC connections. This enables your web application to connect to the system tables. The location of the JAR file must be included in the class path of the web application server.

If you are using WebSphere, and if you allow the installer to create the data source when you install the product, you can skip the step in this procedure about setting the classpath. To enable automatic data source creation during installation, on the Datasource Creation panel, select the **Create Campaign Datasource** check box and supply information about your application server. If you do not want to allow the installer to create the data source, then perform this entire procedure.

If you are using WebLogic, you must perform this entire procedure.

- 1. Consult the *Recommended Software Environments and Minimum System Requirements* document to determine the correct JAR file for your database type.
- 2. Obtain the latest vendor-provided Type 4 JDBC driver that is supported by IBM Marketing Software.
 - If the driver does not exist on the machine where you plan to deploy Campaign, copy the driver to any location on that machine. Unpack the driver in a path that does not include spaces.

- If you obtain the driver from a machine where the data source client is installed, verify that the version is supported.
- 3. Include the full path and file name of the driver in the classpath of the web application server where you plan to deploy Campaign.
 - For all supported versions of WebLogic, set the classpath in the **setDomainEnv** script in the <code>WebLogic_domain_directory/bin</code> directory where environment variables are configured.

The driver must be the first entry in the CLASSPATH list of values before any existing values. For example:

UNIX

Windows

set CLASSPATH=c:\oracle\jdbc\lib\ojdbc7.jar;%PRE_CLASSPATH%;
%WEBLOGIC CLASSPATH%;%POST CLASSPATH%;%WLP POST CLASSPATH%

- For all supported versions of WebSphere, set the classpath in the Administration console when you set up the JDBC providers for the IBM Marketing Software products.
- 4. Restart the web application server so your changes take effect.

 During startup, monitor the console log to confirm that the classpath contains the path to the database driver.

Creating JDBC connections in web application server

Create JDBC connections on each of the web application servers where Campaign is deployed. Campaign uses the JDBC connections to access the required databases.

Use the following list to determine which JDBC connections you must create for the Campaign web application. The steps include the suggested and required JNDI names.

For more information about creating JDBC connections in your web application server, see the WebLogic or WebSphere documentation.

1. Create a connection to the database holding the Marketing Platform system tables. Use UnicaPlatformDS as the JNDI name.

Important: UnicaPlatformDS is the required JNDI name.

If you are deploying Campaign in the same JVM as your Marketing Platform deployment, you have probably already set up this connection.

Note: If you are using WebLogic to configure a connection to an Oracle or DB2 database, you must also specify the database user name in the form user=<DBUser> in the Properties section on the Connection Pool tab.

- 2. Create a connection to the database holding the Campaign system tables. You can allow the installer to create this data source (for one partition only) when you install Campaign. To enable automatic data source creation during installation, on the Datasource Creation panel, select the Create Campaign Datasource check box and supply information about your application server.
 - The installer creates the data source using campaignPartition1DS as the JNDI name.

• Note that, if you are using WebLogic, you must add the JDBC driver to your classpath manually even if you allow the installer to create the data source. The installer does this automatically for WebSphere.

If you do not want to allow the installer to create the data source, then you must create this data source.

If there is one partition, the suggested JNDI name is campaignPartition1DS. If there are multiple partitions,, a best practice is to use campaignPartition1DS for the first connection, campaignPartition2DS for the second, and so on.

Note: This practice is provided as an example. You can specify any JNDI names for Campaign system table connections.

3. Record all JNDI names in the "Campaign installation worksheet" on page 9

Information for creating JDBC connections

Use default values when you create JDBC connections if specific values are not provided. For more information, see the application server documentation.

Note: If you are not using the default port setting for your database, make sure that you change it to the correct value.

WebLogic

Use the following values if your application server is WebLogic:

In the **Database Type** field, select **User-defined**.

After you create the JDBC Provider and data source, go to the **Custom Properties** for the data source, and add, modify properties as follows.

Preparing DB2 on z/OS user datasources for Campaign

Follow these guidelines to use a DB2 database on z/OS as a data source for Campaign.

Campaign supports DB2 10.1 and 11 on z/OS for customer tables only, not system tables. For information about supported versions, see the *Recommended Software Environments and Minimum System Requirements*.

- The database user account must have SYSADM privileges. The DBADM privilege is not sufficient because it does not provide access to all of the required system objects. Without SYSADM privileges, flowcharts might not run successfully.
- 2. Database loaders are supported. However, there is not an out-of-the-box approach for loaders on z/OS. You must set up USS Pipes on z/OS, write a stored procedure to invoke the DSNUTILU and a script to invoke the stored procedure, then configure the loader to invoke the script. For details, see the *IBM Campaign Administrator's Guide*.
- 3. Set **DB2NotLoggedInitially** and **DB2NotLoggedInitiallyUserTables** to FALSE, under Campaign|partitions|partition[n]|dataSources|dataSourcename. For details, see the *IBM Campaign Administrator's Guide*.

Preparing Vertica datasources for Campaign

Follow these guidelines to use a Vertica database as a data source for Campaign.

Preparing Amazon Redshift user data sources for Campaign

Follow these guidelines to use Amazon Redshift as a data source for Campaign.

Campaign supports Amazon Redshift for customer tables. Redshift is not supported for system tables.

Use the PostgreSQL ODBC driver for connectivity and configure the PostgreSQL template in Campaign for each datasource. See the *IBM Campaign Administrator's Guide* for important information about configuring

Campaign|partitions|partition[n]|dataSources|PostgreSQL. Some properties do not have default values, so you must supply them. Other properties might need to be adjusted for your specific configuration.

For information about supported versions, see the *Recommended Software Environments and Minimum System Requirements*. For information about Amazon Redshift, see http://aws.amazon.com/redshift/.

- 1. Download and configure the PostgreSQL ODBC driver for Redshift.
- 2. Validate connection and authentication details: Use isql to test the connection on Linux. Use the Microsoft Windows ODBC Driver Manager for Windows.
- Import PostgreSQLTemplate.xml using configTool (a utility supplied with IBM Marketing Platform).
- 4. Fill in the newly added PostgreSQL template with the user database details.
- 5. Configure the Amazon Redshift user database.
- 6. Restart the application server and the IBM Campaign listener server.

Follow the steps below to test the connection with Amazon Redshift.

- 2. Configure ODBCINI to point to the odbc.ini file location.



 - DataDirect Apache Hive ODBC driver from Progress.com: DataDirect Connect64(R) for ODBC Release 7.1.5.
 - Cloudera ODBC Driver for Apache Hive Version 2.5.16 for Apache Hadoop Hive from Cloudera, Inc.
 - Hortonworks 64-bit ODBC driver for HDP 2.3 (v2.0.5) available at http://hortonworks.com/hdp/addons/.
- The following Hadoop distributions are supported, with Apache Hive as the connection point: Cloudera, Hortonworks, IBM BigInsights^{® ™}, MapR.
- Minimum supported Hive version: 0.14
- The big data integration is currently supported on Linux RHEL 6.3 or higher.
- Hive-based Hadoop is supported as a user data source only. It is not supported for Campaign system tables.
- The big data integration does not currently support the IBM Campaign Cube, Optimize, or Interact List process boxes or eMessage Landing Pages in an Extract process box.

Overview of the Campaign integration with Hadoop

Integrating Campaign with Hadoop data sources demands extra software that is not part of the standard Campaign installation requirement. You must be familiar with the terminology and structure of the integration, and be able to access various resources that are available to support the integration.

Integration architecture: Hive-based Hadoop and Campaign

This diagram shows the integration architecture for IBM Campaign and Hive-based Hadoop user data sources.



The Apache Hive data warehouse software facilitates querying and managing large datasets that reside in distributed storage. Built on top of Apache Hadoop, Hive provides:

- Tools to enable easy data extract/transform/load (ETL)
- A mechanism to impose structure on a variety of data formats
- Access to files stored either directly in Apache HDFS or in other data storage systems such as Apache HBase
- Query execution via MapReduce

Hive defines a simple SQL-like query language, called HiveQL (or HQL), that enables users familiar with SQL to query the data.

You can use the Hue editor (Hadoop UI) to work with your big data instance (for example: connect, view, create tables and databases).

Terminology and resources for Hive Hadoop

To understand the Hive Hadoop integration with IBM Campaign, refer to this list of definitions and links to online resources.

Terms

Apache Hadoop[®] is an open-source software framework written in Java for distributed storage and distributed processing of very large data sets on computer clusters built from commodity hardware.

Apache Hive[™] is a data warehouse infrastructure built on top of Hadoop to facilitate querying and managing large datasets that reside in distributed storage. Hive provides a mechanism to project structure onto this data and query the data using an SQL-like language called HiveQL.

Apache HBase[™] is an open source, non-relational, distributed database written in Java. It runs on top of HDFS, providing BigTable-like capabilities for Hadoop.

Hadoop Distributed File System (HDFS^{$^{\text{TM}}$}) is a distributed file system that runs on commodity hardware. It is designed to reliably store very large files across machines in a large cluster.

Hue is a Web interface for analyzing data with Apache Hadoop.

HiveQL (or HQL) is the Hive query language.

MapReduce is a programming model and an associated implementation for processing and generating large data sets with a parallel, distributed algorithm on a cluster. MapReduce is the heart of Hadoop[®]. It is this programming paradigm that allows for massive scalability across hundreds or thousands of servers in a Hadoop cluster.

Big data **distributions** of Apache Hadoop: A number of vendors have developed their own distributions of Hadoop, including **Cloudera**, **Hortonworks**, **IBM BigInsights**, and **MapR**.

User tables is an IBM Campaign term that indicates any data source that contains an organization's marketing data for access by IBM Campaign flowcharts. Typically, user tables contain data about customers, prospects, and products. For example, customer account data pulled from user tables could be used in a

flowchart to target customers with specific account types and balances.

This is the first step to integrate IBM Campaign with Hive-based Apache Hadoop data sources. You must install either the DataDirect Hive ODBC Driver from Progress Software or the Cloudera Hive ODBC driver from Cloudera, Inc.

You can install any one of the Hive ODBC drivers that are described below. Be sure to follow the appropriate instructions for the driver that you select.

Install the Hive ODBC driver on the system where you have installed the Campaign Analytical Server. If the Analytical Server is installed in a cluster, install the Hive ODBC driver on each system.

Installing the DataDirect Hive ODBC driver

This topic explains how to install the DataDirect driver for Apache Hive, which is a fully compliant ODBC driver that supports multiple Hadoop distributions.

KornShell (ksh) must be installed on the IBM Campaign listener (analytic) server.

- 1. Obtain the Progress DataDirect Connect ODBC driver (Progress DataDirect Connect64(R) for ODBC Release 7.1.5) for Apache Hadoop Hive: https://www.progress.com/products/data-sources/apache-hadoop-hive
- 2. Download and install the DataDirect Hive driver on the IBM Campaign listener (analytic server):

[DataDirectNew]# gunzip

PROGRESS_DATADIRECT_CONNECT64_ODBC_7.1.5_LINUX_64.tar.Z

PROGRESS_DATADIRECT_CONNECT64_ODBC_7.1.5_LINUX_64.tar

- 3. Run the following command to start the installation:
 - >> ksh ./unixmi.ksh
- 4. Follow the prompts to complete the installation.
- 5. Perform basic testing of the driver:
 - >> ./ddtestlib /opt/Progress/DataDirect/Connect64_for_ODBC_71/lib/ddhive27.so

- 1. Obtain the Cloudera ODBC Driver for Apache Hive Version 2.5.16 for Apache Hadoop Hive at http://www.cloudera.com/content/cloudera/en/downloads/connectors/hive/odbc/hive-odbc-v2-5-16.html. Download and save the Cloudera Hive ODBC driver on the IBM Campaign listener (analytic server). The default location is /opt/cloudera/.
- 2. Install and configure the Cloudera driver. Installation instructions are downloaded to where you install the driver. By default, the instructions are downloaded to /opt/cloudera/hiveodbc/Cloudera-ODBC-Driver-for-Apache-Hive-Install-Guide.pdf. The PDF file is also available online at www.cloudera.com.
- 3. Download and install UnixODBC Manager, unixODBC-2.3.2 on the IBM Campaign listener (analytic server). Download UnixODBC Manager from the unixODBC Project at http://www.unixodbc.org/. The UnixODBC Manager is available in a gzip, tar format.

The steps to install UnixODBC are available at http://www.unixodbc.org/download.html

To create a unixODBC directory that contains the required source files:

- a. Copy the unixODBC-2.3.2.tar.gz file to the Campaign listener (analytic server).
- b. gunzip unixODBC-2.3.2.tar.gz
- c. tar xvf unixODBC-2.3.2.tar
- 4. On the Campaign listener, run rpm -ivh ClouderaHiveODBC-2.5.16.1005-1.el6.x86 64.rpm.

- 1. Obtain the 64-bit version of the Hortonworks Hive ODBC driver: http://hortonworks.com/hdp/addons
- 2. Install the Hortonworks ODBC driver on the IBM Campaign listener (analytic server):

rpm -ivh hive-odbc-native-2.0.5.1005-1.el6.x86_64.rpm

The default installation location of the Hortonworks Hive ODBC driver is /usr/lib/hive/lib/native.

Log in as the user who is running the IBM Campaign listener and run the following commands, substituting the username@IP address of your Hive server (in this example, the MapR machine):

D. Configure SSH on the Campaign listener server

This is the fourth step to integrate IBM Campaign with Impala-based Cloudera Hadoop data sources.

To enable data file transfers between the IBM Campaign listener (analytic) server and the Impala-based Hadoop big data instance, you must configure SCP and SSH seamless login. SSH allows secure connection between two computers; most systems use the OpenSSH client.

- On the machine that is running the IBM Campaign listener, configure SSH for no password prompt for authentication. Log in as the user who is running the IBM Campaign listener and run the following commands, substituting the username@IP address of your Impala server (in this example, the MapR machine):
 - >> ssh-keygen -t rsa
 - >> ssh cloudera@192.0.2.0 mkdir -p .ssh

- >> cat .ssh/id_rsa.pub | ssh cloudera@192.0.2.0 'cat >> .ssh/authorized_keys' >> ssh cloudera@192.0.2.0 "chmod 700 .ssh; chmod 640 .ssh/authorized keys"
- 2. Verify password-less authentication using RSA-based authorized keys. Run each command, substituting the actual **username@IP address**, and verify that it works. You need a local file called test1 for this test to work:
 - >> ssh cloudera@192.0.2.0
 - >> scp test1 cloudera@192.0.2.0:/tmp
 - >> ssh cloudera@192.0.2.0 "rm /tmp/test1"

E. Map the Impala datasource in Campaign

This is the Fifth and final step to integrate IBM Campaign with Impala-based Hadoop data sources.

Mapping user tables makes external data sources accessible in Campaign. A typical user table contains information about your company's customers, prospects, or products, for use in marketing campaigns. You must map any data sources that you configured to make that data accessible to processes in flowcharts.

- 1. Select Settings > Campaign Settings > Manage Table Mappings.
- 2. In the Table Mappings dialog, click **Show User Tables**.
- 3. Click New Table. The New Table Definition dialog opens.
- 4. Click Next.
- 5. Select Map to Existing Table in Selected Database.
- 6. Select the BigDataODBCImpala datasource, then click Next.
- 7. Follow the prompts to map the table, as explained in the *IBM Campaign Administrator's Guide*.

You have completed the installation and configuration process. IBM Campaign flowchart designers can now select Impala-based Hadoop data sources in processes. For example, a Select process can query a Impala-based data source to target customer data for a marketing campaign.

Chapter 4. Installing Campaign

You must run the IBM Marketing Software installer to start the installation of Campaign. The IBM Marketing Software installer starts the Campaign installer during the installation process. Make sure that the IBM Marketing Software installer and the product installer are saved at the same location.

Each time that you run the IBM Marketing Software suite installer, you must first enter database connection information for the Marketing Platform system tables. When the Campaign installer starts, you must enter the required information for Campaign.

After installing Campaign, you can create an EAR file for your product, and you can install the reports package for your product. Creating the EAR file and installing the reports package are not mandatory actions.

Important: Before you install Campaign, make sure that the available temporary space on the computer where you install Campaign is more than three times the size of the Campaign installer.

Note: Information about using web application clustering in IBM Campaign is provided in Chapter 12, "IBM Campaign web application clustering," on page 107.

Installation files

The installation files are named according to the version of the product and the operating system on which they must be installed, except UNIX. For UNIX, different installation files exist for the X Window System mode and the console mode.

The following table displays examples of the installation files that are named according to the product version and the operating system:

Table 5. Installation files

Operating system	Installation file
Windows: GUI and console mode	Product_N.N.N_win64.exe, where Product is the name of your product, N.N.N.N is the version number of your product, and Windows 64-bit is the operating system on which the file must be installed.
UNIX: X Window System mode	<pre>Product_N.N.N.N_linux64.bin, where Product is the name of your product, and N.N.N.N is the version number of your product.</pre>
UNIX: Console mode	Product_N.N.N.bin, where Product is the name of your product, and N.N.N.N is the version number of your product. This file can be used for installation on all UNIX operating systems.

Installing Campaign by using the GUI mode

For Windows, use the GUI mode to install Campaign. For UNIX, use the X Window System mode to install Campaign.

Important: Before you use the GUI mode to install Campaign, make sure that the available temporary space on the computer where you install Campaign is more than three times the size of the Campaign installer.

Make sure that the IBM Marketing Software installer and the Campaign installers are in the same directory on the computer where you want to install Campaign.

Complete the following actions to install Campaign by using the GUI mode:

- 1. Go to the folder where you have saved the IBM Marketing Software installer and double-click the installer to start it.
- 2. Click **OK** on the first screen to see the Introduction window.
- 3. Follow the instructions on the installer, and click **Next**. Use the information in the following table to take the appropriate actions on each window in the IBM Marketing Software installer.

Creating an EAR file after running the installer

You can create an EAR file after you install IBM Marketing Software products. You might do this to create an EAR file with a desired combination of products.

Note: Run the installer in console mode from the command line.

Use the following procedure if you want to create an EAR file after you install IBM Marketing Software products:

- If this is the first time you are running the installer in console mode, make a backup copy of the installer's .properties file for each of your installed products.
 - Each IBM product installer creates one or more response files with a .properties extension. These files are in the same directory where you placed the installers. Be sure to back up all files with the .properties extension, including the installer_product initials>product version number>.properties files and the file for the IBM installer itself, which is named installer.properties.</code>

For example, the properties files for Marketing Platform installer_ump11.0.1.0.properties and the properties file for Optimize installer_uo11.0.1.0.properties.

- If you plan to run the installer in unattended mode, you must back up the original .properties files, because when the installer runs in unattended mode, it clears these files. To create an EAR file, you need the information that the installer writes in the .properties files during the initial installation.
- 2. Open a command window and change directories to the directory that contains the installer.
- 3. Run the installer executable with this option:
 - -DUNICA GOTO CREATEEARFILE=TRUE
 - On UNIX type systems, run the .bin file rather than the .sh file.
 - The installer wizard runs.
- 4. Follow the instructions in the wizard.
- 5. Before you create more EAR files, overwrite the .properties file or files with the backups you created before you ran in console mode for the first time.

Installing Campaign using the console mode

The console mode allows you to install Campaign using the command-line window. You can select various options in the command-line window to complete tasks such as selecting the products to install, or selecting the home directory for the installation.

Before you install Campaign, ensure that you have configured the following.

- · An application server profile
- A database schema

To display the installer screens correctly in console mode, configure your terminal software to support UTF-8 character encoding. Other character encodings, such as ANSI, do not render the text correctly, and some information is not readable with these encodings.

- 1. Open a command-line prompt window and navigate to the directory where you have saved the IBM Marketing Software installer and the Campaign installer.
- Complete one of the following actions to run the IBM Marketing Software installer.
 - For Windows, enter the following command:

```
ibm_ims_installer_full_name -i console
For example, IBM_Marketing_Software_Installer_11.0.1.0_win.exe -i
console
```

- For UNIX, invoke the ibm_ims_installer_full_name.sh file.
 For example: IBM_Marketing_Software_Installer_11.0.1.0.sh
- 3. Follow the directions that are displayed in the command-line prompt. Use the following guidelines when you have to select an option in the command-line prompt:
 - The default options are defined by the symbol [X].
 - To select or clear an option, type the number that is defined for the option, and then press Enter.

For example, suppose that the following list displays the components that you can install:

- 1 [X] Marketing Platform
- 2 [X] Campaign

3	[]	Contact	Optimization
---	---	---	---------	--------------

4 [] Distributed Marketing

If you want to install Distributed Marketing, and do not want to install Campaign, enter the following command: **2,4**

The following list would then display the options that you selected:

- 1 [X] Marketing Platform
- 2 [] Campaign
- 3 [] Contact Optimization
- 4 [X] Distributed Marketing

Note: Do not clear the option for Marketing Platform unless you have already installed it.

- 4. The IBM Marketing Software installer launches the Campaign installer during the installation process. Follow the instructions in the command-line prompt window of the Campaign installer.
- 5. After you enter quit in the Campaign installer command-line prompt window, the window shuts down. Follow the instructions in the command-line prompt window of the IBM Marketing Software installer to complete the installation of Campaign.

Note: If any error occurs during the installation, a log file is generated. You must exit the installer to view the log file.

Installing Campaign silently

Use the unattended or silent mode to install Campaign multiple times.

Before you install Campaign, make sure that you have configured the following elements:

- An application server profile
- A database schema

When you install Campaign by using the silent mode, response files are used to obtain the information that is required during installation. You must create response files for a silent installation of your product. You can create response files by using one of the following methods:

- Using the sample response files as a template for creating your response files. The sample response files are included with your product installers in the ResponseFiles compressed archive. For more information about sample response files, see "Sample response files" on page 49.
- Running the product installers in the GUI (Windows) or X Window System (UNIX) mode or the console mode before you install the product in the silent mode. One response file is created for the IBM Marketing Software suite installer, and one or more response files are created for your product installer. The files are created in the directory that you specify.

Important: For security reasons, the installer does not save database passwords in the response files. When you create response files, you must edit each response file to enter database passwords. Open each response file and search for PASSWORD to find where you must edit the response file.

When the installer runs in the silent mode, it looks for the response files in the following directories sequentially:

- In the directory where the IBM Marketing Software installer is saved
- In the home directory of the user who installs the product

Make sure that all response files are in the same directory. You can change the path where response files are read by adding arguments to the command line. For example: -DUNICA_REPLAY_READ_DIR="myDirPath" -f myDirPath/installer.properties

Use the following command for Windows:

• *ibm_ims_installer_full_name* -i silent For example:

IBM_Marketing_Software_Installer_11.0.1.0_win.exe -i silent
Use the following command for Linux:

• ibm_ims_installer_full_name _operating_system .bin -i silent For example:

IBM_Marketing_Software_Installer_11.0.1.0_linux.bin -i silent

Sample response files

You must create response files to set up a silent installation of Campaign. You can use sample response files to create your response files. The sample response files are included with the installers in the ResponseFiles compressed archive.

The following table provides information about sample response files:

Table 9. Description of sample response files

Sample response file	Description
installer.properties	The sample response file for the IBM Marketing Software master installer.
<pre>installer_product initials and product version number.properties</pre>	The sample response file for the Campaign installer. For example, installer_ucn.n.n.properties is the response file of the Campaign installer, where n.n.n.n is the version number.

Chapter 5. Configuring Campaign before deployment

Before you deploy Campaign, create and populate the Campaign and eMessage system tables and register Campaignand eMessage manually.

Note: Information about using web application clustering in IBM Campaign is provided in Chapter 12, "IBM Campaign web application clustering," on page 107.

Creating and populating Campaign system tables manually

By default, the Campaign installer automatically creates and populates system tables. However, if the system tables are not created and populated automatically during the installation, you must populate the system tables manually. Use your database client to run the Campaign SQL scripts against the appropriate database to create and populate the Campaign system tables.

Note: If you plan to enable eMessage, you must also manually create and populate the eMessage system tables if the installer did not do so automatically. For details, see "Creating and populating the eMessage system tables manually" on page 52.

If you selected the **Campaign System Table DDL Files** option on the Campaign Components page during installation, the IBM installer installs a collection of SQL scripts that you can use to create and populate the Campaign system tables. The SQL scripts are installed in the ddl directory under your installation of the Campaign server. If your system tables are configured for Unicode, the appropriate scripts are in the ddl/unicode directory under your Campaign installation.

To use the SQL scripts, run your database client to apply the scripts to the database or schema that holds the Campaign system tables. See the documentation for your database software for instructions on running SQL scripts.

The following tables list the SQL scripts that are provided for you to use to create and populate the Campaign system tables manually:

To populate the rows in the system tables that are created by the clb_systab_DB_type.sql script, run the clb_populate_tables.sql script.

Creating and populating the eMessage system tables manually

For eMessage, you must create additional system tables in the Campaign schema and then populate the tables with initial data. The Campaign installer automatically creates and populates the eMessage system tables in the Campaign schema if you select the option to create system tables automatically. However, if you do not select the option, you must create and populate the eMessage system tables manually.

Use your database client to run the appropriate script against the Campaign database.

Note: The eMessage installation directory is a subfolder within the Campaign directory.

Scripts for creating eMessage tables

IBM provides the ace_op_systab scripts for creating eMessage tables in your local environment.

If your Campaign system tables are configured for Unicode, find the appropriate script in the ddl/unicode directory under your eMessage installation.

If your Campaign system tables are not configured for Unicode, use the non-Unicode scripts in the ddl directory under your eMessage installation. Use the following table to see the scripts that you must use:

Table 13. Scripts for creating eMessage tables

Data source type	Script name

Scripts for populating eMessage tables

IBM provides the ace_op_populate_systab scripts for populating the eMessage tables in your local environment.

The populate scripts are stored in the ddl directory of your eMessage installation. IBM provides only one version of the populate scripts because you can use them for either Unicode or non-Unicode tables.

Note: The eMessage installation directory is a subfolder within the Campaign directory.

Use the following table to see the scripts that you must use:

Registering Campaign manually

During the installation process. if the Campaign installer cannot access the Marketing Platform system tables, you must run the **configTool** utility to register it manually.

You can use the **configTool** and **populateDb** utilities to import and populate the Campaign information in the Marketing Platform system tables.

1. Run the **populateDb** utility by using the following example command as a guideline.

```
populateDb.bat -n Campaign
```

The command imports security roles and permissions into the default partition.

2. **If you are upgrading Campaign**, unregister Campaign by using the following command:

```
configTool -x -p "Affinium Campaign about" -f exportedAbout.xml
```

The command exports the Campaign **About** node to the exportedAbout.xml file.

- 3. Run the configTool utility by using the following example commands as guidelines:
 - configTool -r Campaign -f
 "full_path_to_Campaign_installation_directory\conf\
 campaign configuration.xml"
 - configTool -v -i -p "Affinium|suite|uiNavigation|settingsMenu" -f
 "full_path_to_Campaign_installation_directory\conf\
 campaign_setup_navigation.xml"
 - configTool -v -i -p "Affinium|suite|uiNavigation|mainMenu" -f "full_path_to_Campaign_installation_directory\conf\ campaign navigation.xml"

- configTool -v -i -p "Affinium|suite|uiNavigation|mainMenu|Analytics"
 -f "full_path_to_Campaign_installation_directory\conf\
 campaign_analysis_navigation.xml"
- configTool -v -i -p "Affinium|suite|uiNavigation|alerts" -f
 "full_path_to_Campaign_installation_directory\conf\
 campaign alerts.xml"

The commands import configuration properties and menu items. You must run the utility as many times as there are files.

4. Run the following command after you register Campaign:

configtool -i -p "Affinium | Campaign" -f exportedAbout.xml

The command imports the Campaign **About** node to the exportedAbout.xml file.

Registering eMessage manually

During the installation process. if the eMessage installer cannot access the Marketing Platform system tables, you must run the **configTool** utility to register it manually.

By default, the Campaign installer automatically registers eMessage with the Marketing Platform system tables without enabling eMessage. In some situations, the Campaign installer does not connect with the Marketing Platform system tables to automatically register eMessage.

If the installer does not register eMessage automatically, you must register eMessage manually with the configTool utility that is provided with the IBM Marketing Software installation. The configTool utility is in the tools\bin directory under your Marketing Platform installation.

To register eMessage manually, use the following command to run the configTool utility:

configTool -r eMessage -f "full_path_to_eMessage_installation_directory\
conf\emessage_configuration.xml"

The eMessage installation directory is a subdirectory of the Campaign installation directory.

For more information about registering and configuring eMessage, see the *IBM eMessage Startup and Administrator's Guide*.

Setting data source variables in the Campaign startup script (UNIX only)

Data source variables are automatically set by the installer during installation of Campaign. You can change these settings in the Campaign/bin/setenv.sh file. You must restart the server every time you modify the setenv.sh file.

During Campaign installation, the IBM Installer collects database information from you and uses that information to automatically configure the database and environment variables that are required to create and use the Campaign system tables. Those settings are stored in the setenv.sh file in the bin directory under your Campaign server installation.

For access to data sources (such as Campaign customer tables) that do not use the same type of database as the system tables, you must manually configure the setenv.sh file to add the database and library environment variables that are described in "Database and library environment variables."

Note that if you modify this file when the Campaign server is already running, you must restart the server before changes to the setenv file are recognized. See "Starting the Campaign server" on page 62 for more details.

See Distributed Marketing database information worksheet for the required information to add to the seteny file.

Database and library environment variables

Set database and library environment variables that are required for your databases (customer tables and system tables, if you chose Manual Database Setup during installation) and operating system. You can set the database and library variables in the setenv.sh file.

HP-UX	SHLIB_PATH
	For example: SHLIB_PATH= <campaign_home>/bin:<path db="" directory="" lib="" to="">:/usr/lib:\$ORACLE_HOME/lib32:\$ORACLE_HOME/lib</path></campaign_home>

Library directories for Oracle databases

Different versions of Oracle have different naming conventions for their lib directories. Older versions used lib for 32-bit and lib64 for 64-bit. Newer versions use lib32 for 32-bit and lib for 64-bit.

If you install 32-bit Campaign, you must include either \$0RACLE_HOME/1ib32 or \$0RACLE_HOME/1ib, whichever one contains the 32-bit Oracle libraries.

If you install 64-bit Campaign, you must include either <code>\$ORACLE_HOME/lib</code> or <code>\$ORACLE_HOME/lib64</code>, whichever one contains the 64-bit Oracle libraries.

Note: Do not include paths to both the 32- and 64-bit libraries; include only the path to the library you are using for your version of Campaign.

Chapter 6. Deploying the Campaign web application

You can deploy the Campaign web application by using an EAR file or you can deploy the individual WAR files.

To deploy Campaign, follow the guidelines in this section and then start the Campaign server.

When you ran the IBM installer, you may have included Campaign in an EAR file, or you may choose to deploy the Campaign WAR file. If you included the Marketing Platform or other products in an EAR file, you must follow all the deployment guidelines detailed in the individual install guides for the products included in the EAR file.

You must know how to work with your web application server. Consult your web application server documentation for details such as navigation in the Administration console.

Note: Information about using web application clustering in IBM Campaign is provided in Chapter 12, "IBM Campaign web application clustering," on page 107.

Setting the web application session timeout

Session timeout determines how long an inactive HTTP session can remain open before the session expires. If required, you can set the web application session timeout for Campaign by using the WebSphere console or the WebLogic console to adjust the value of session timeout in seconds or minutes.

Set the session timeout on your web application server:

- WebSphere: Use the IBM WebSphere Application Server Administrative Console to set the Session timeout in minutes. You can adjust this setting at the server and Enterprise Application levels. See your WebSphere documentation for details.
- WebLogic: Use the WebLogic console to set the Session Timeout in seconds, or adjust the TimeoutSecs parameter value for the session-descriptor element in the weblogic.xml file.

Deploying Campaign on WebSphere Application Server

You can deploy Campaign runtime environment on supported versions of WebSphere Application Server (WAS) from a WAR file or EAR file.

- Make sure that multiple language encoding is enabled in WAS.
- When you run the Install New Application wizard, ensure that you set the JDK Source Level to 17.

Important: If you are using IBM WebSphere Application Server 8.5.5.x Fix Pack 9 or earlier, you must use the following workaround to disable the annotation scanning for the xstream jar and to allow the application to be deployed correctly.

Go to the app_server_root/properties folder in the WebSphere installation. In the amm.filter.properties file, add the following line under Ignore-Scanning-Packages.

Deploying Campaign on WAS from a WAR file

You can deploy the Campaign application from a WAR file on WAS.

Complete the following tasks before you deploy Campaign:

- Confirm that your version of WebSphere meets the requirements in the *Recommended Software Environments and Minimum System Requirements* document, including any necessary fix packs or upgrades.
- Confirm that you created the data sources and database provider in WebSphere.
- Please follow the below steps while deploying Campaign.war file on IBM Websphere Application Server 8.5.5.x Fix Pack 9 or below versions
 - a) Go to <app_server_install_directory>/properties location

Example: /data/webservers/IBM/WebSphere8.5.5/properties

b) Edit "amm.filter.properties" file to include "com.thoughtworks.xstream" Example:

```
Ignore-Scanning-Packages = javassist, \
org.antlr, \
org.apache.avalon, \
org.apache.batik, \
org.apache.bcel, \
org.apache.commons, \
org.apache.log4j, \
org.apache.poi, \
org.apache.regexp, \
org.apache.xalan, \

org.ajax4jsf, \
org.dbunit, \
org.richfaces, \
org.jboss.el, \

com.thoughtworks.xstream

By doing this, WebSphere will disable the annotation scanning for the xstream jar

and allow the application deployed properly.

This is also mentioned in here http://x-stream.github.io/faq.html

This steps are not required for Websphere version 8.5.0.x or 8.5.5 Fix Pack 10 or higher.

- 1. Go to the WebSphere Integrated Solutions Console.
- 2. Complete the following steps if your system tables are in DB2:

- a. Click the data source that you created. Go to the Custom Properties for the data source.
- b. Select the Custom properties link.
- c. Set the value for the resultSetHoldability property to 1.
 If you do not see the resultSetHoldability property, create the resultSetHoldability property and set its value to 1.
- 3. Go to Applications > Application Types > WebSphere enterprise applications and click Install.
- 4. In the Preparing for the application installation window, select the **Detailed Show all options and parameters** check box and click **Next**.
- 5. Click **Continue** to see the Install New Application wizard.
- 6. Accept the default settings on the windows of the Install New Application wizard except the following windows:
 - In step 1 of the Install New Application wizard, select the **Precompile JavaServer Pages files** check box.
 - In step 3 of the installation wizard, set the **JDK Source Level** to 17.
 - In step 9 of the installation wizard, set the **Context Root** to /Campaign.
- 7. In the left navigation panel of WebSphere Integrated Solutions Console, navigate to **Applications > Application Types > WebSphere enterprise applications**.
- 8. In the Enterprise Applications window, click the Campaign.war file.
- 9. In the **Web Module Properties** section, click **Session Management** and select the following check boxes:
 - · Override session management
 - Enable Cookies
- Click Enable Cookies, and in the Cookie name field, enter a unique cookie name.
- 11. If you are using version 8 of WebSphere Application Server, select Servers > WebSphere application server > server 1 > Session management > Enable Cookies and clear the check box for Set session cookies to HTTPOnly to help prevent cross-site scripting attacks.
- 12. In the **Applications > Enterprise Applications** section of the server, select the WAR file that you deployed.
- 13. In the Detail Properties section, select Class loading and update detection.
- 14. In the Class loader order section, select the Classes loaded with local class loader first (parent last) option.
- 15. For WAR class loader policy, select Single class loader for application.
- 16. Start your deployment.

Deploying Campaign on WAS from an EAR file

You can deploy Campaign by using an EAR file if you included Campaign in an EAR file when you ran the IBM Marketing Software installer.

- Confirm that your version of WebSphere meets the requirements in the *Recommended Software Environments and Minimum System Requirements* document, including any necessary fix packs or upgrades.
- Confirm that you created the data sources and database provider in WebSphere.
- 1. Go to the WebSphere Integrated Solutions Console.
- 2. Complete the following steps, if your system tables are in DB2:

- a. Click the data source that you created. Go to the **Custom Properties** for the data source.
- b. Select the Custom properties link.
- c. Set the value for the resultSetHoldability property to 1.
 If you do not see the resultSetHoldability property, create the resultSetHoldability property and set its value to 1.
- 3. Go to Applications > Application Types > WebSphere enterprise applications and click Install.
- 4. In the Preparing for the application installation window, select the **Detailed Show all options and parameters** check box and click **Next**.
- 5. Click **Continue** to see the Install New Application wizard.
- 6. Accept the default settings on the windows of the Install New Application wizard except the following windows:
 - In step 1 of the Install New Application wizard, select the **Precompile JavaServer Pages files** check box.
 - In step 3 of the installation wizard, set the **JDK Source Level** to 17.
 - In step 8 of the installation wizard, set the **Context Root** to /Campaign.
- 7. In the left navigation panel of WebSphere Integrated Solutions Console, navigate to **Applications > Application Types > WebSphere enterprise applications**.
- 8. In the Enterprise Applications window, select the EAR file that you want to deploy.
- 9. In the **Web Module Properties** section, click **Session Management** and select the following check boxes:
 - · Override session management
 - Enable Cookies
- 10. Click **Enable Cookies**, and in the **Cookie name** field, enter a unique cookie name.
- 11. If you are using version 8 of WebSphere Application Server, select Servers > WebSphere application server > server 1 > Session management > Enable Cookies and clear the check box for Set session cookies to HTTPOnly to help prevent cross-site scripting attacks.
- 12. In the Detail Properties section, select Class loading and update detection.
- 13. In the Class loader order section, select the Classes loaded with local class loader first (parent last) option.
- 14. For WAR class loader policy, select the Class loader for each WAR file in application option.
- 15. In Websphere Enterprise Applications, select *Your Application* > Manage Modules > *Your Application* > Class Loader Order > Classes loaded with local class loader first (parent last).
- **16**. Start your deployment.

For more information about WebSphere Application Server version 8.5, see Welcome to the WebSphere Application Server information center.

Deploying Campaign on WebLogic

You can deploy IBM Marketing Software products on WebLogic.

Use the following guidelines when you deploy Campaign on WebLogic:

- IBM Marketing Software products customize the JVM used by WebLogic. You might need to create a WebLogic instance that is dedicated to IBM Marketing Software products if you encounter JVM-related errors.
- Verify that the SDK selected for the WebLogic domain you are using is the Sun SDK by looking in the startup script (startWebLogic.cmd) for the JAVA_VENDOR variable. It should be set to: JAVA_VENDOR=Sun. If it is set to JAVA_VENDOR=BEA, JRockit has been selected. JRockit is not supported. To change the selected SDK, refer to the WebLogic documentation.
- Deploy the IBM Marketing Software products as web application modules.
- On UNIX systems, you must start WebLogic from the console to allow correct rendering of graphical charts. The console is usually the machine on which the server is running. However, in some cases the web application server is set up differently.

If a console is not accessible or does not exist, you can emulate a console using Exceed. You must configure Exceed so that your local Xserver process connects to the UNIX machine in root window or single window mode. If you start the web application server using Exceed, you must keep Exceed running in the background to allow the web application server to continue running. Contact IBM Technical Support for detailed instructions if you encounter problems with chart rendering.

Connecting to the UNIX machine via telnet or SSH always causes problems rendering charts.

- If you are configuring WebLogic to use the IIS plug-in, review the WebLogic documentation.
- If you are deploying in a production environment, set the JVM memory heap size parameters to at least 1024 by adding the following line to the setDomainEnv script:

Set MEM_ARGS=-Xms1024m -Xmx1024m -XX:MaxPermSize=256m

 Under certain circumstances, deploying older legacy interactive channels or interactive channels with large deployment histories can stress the system and require 2048mb or greater of Campaign designtime and/or Interact runtime Java heap space.

System administrators can adjust the amount of memory available to the deployment systems via the following JVM parameters:

-Xms####m -Xmx####m -XX:MaxPermSize=256m

Where the characters #### should be 2048 or higher (depending on their system load.) Note that a 64-bit application server and JVM are usually necessary for values greater than 2048.

These are the suggested minimum values. Analyze your sizing requirements to determine correct values for your needs.

Configuring WebLogic to display reports (UNIX)

If you install Campaign with Contact Optimization on a UNIX system, you must enable the <code>java.awt.headless</code> JVM property so that the WebLogic web application server can display the graphs in Contact Optimization reports.

To enable graph display in Optimize reports in the WebLogic JVM:

- 1. Shut down the WebLogic server if it is already running.
- 2. Locate and open the startup script for your WebLogic server (startWebLogic.sh) in any text editor.
- 3. Modify the JAVA_OPTIONS parameter to add the following value:

-Djava.awt.headless=true

4. Save the startup script, then restart the WebLogic server.

Starting the Campaign server

Make sure that Marketing Platform and Campaign web applications are deployed and running when you start the Campaign server.

You can start the Campaign server directly, or install it as a service.

Starting the Campaign listener manually

Start the Campaign listener by running the cmpServer.bat file for Windows, or the rc.unica_ac command for UNIX.

Follow the instructions appropriate for your operating system.

Windows

Start the Campaign listener by running the cmpServer.bat file in the bin directory under your Campaign installation. When the unica_aclsnr.exe process appears on the Windows Task Manager Processes tab, the server has started successfully.

UNIX

Start the Campaign listener by executing the rc.unica_ac program with a start argument. You must run this command as root. For example:

```
./rc.unica ac start
```

To determine whether the unica_aclsnr process has started successfully, enter this command:

```
ps -ef | grep unica aclsnr
```

To determine the process ID for the server you started, view the unica_aclsnr.pid file located in the conf directory under your Campaign installation.

Note: Since Campaign supports listener clustering, a loop is added in the rc.unica_ac which automatically restarts the listener if in case the listener goes down or crashes. Also, process rc.unica_ac still remains after starting listener and the parent process may change. For example, if you are upgrading from Release 8.6.0.4 to Release 9.1.1, the parent process of unica_aclsnr can be changed to rc.unica_ac instead of init, which was the former parent process and the process rc.unica_ac still remains after starting the listener.

Installing the Campaign listener as a Windows service

You can install the Campaign listener as a Windows service so that it starts automatically whenever you start Windows.

1. Add the bin directory under the Campaign installation directory to the user PATH environment variable. If the PATH environment variable does not exist for the user, create it.

Make sure that you add this path to the user PATH variable, not the system PATH variable.

If the Campaign bin directory exists in the system PATH environment variable, remove it. You do not need it in the system PATH environment variable to install the Campaign listener as a service.

- 2. If you are upgrading from a previous version of Campaign that had the server installed as a service, stop the service.
- 3. Open a command window and change directories to the bin directory under your Campaign installation.
- 4. Run the following command to install the Campaign listener as a Windows service:

```
unica_aclsnr -a
```

Note: The -a option includes auto-restart functionality. If you do not want the service to attempt to restart automatically, use unica_aclsnr -i.

The listener is now installed as a service.

Note: Make sure CAMPAIGN_HOME has been created as a system environment variable before starting the Campaign listener service.

- 5. Open the Unica Campaign Listener Service properties dialog box. Click the **Log On** tab.
- 6. Select **This account**.
- 7. Enter the user name (system user) and password, and start the services.

Chapter 7. Configuring after deployment

After you deploy Campaign, you must verify that the Campaign listener is running, set up the Campaign system user, set Campaign configuration properties, and verify the Campaign installation.

If you are using the IBM Marketing Software reporting feature, you must complete the tasks that are described in the *IBM Marketing Software Reports Installation and Configuration Guide*.

Note: If you plan to enable IBM eMessage for hosted email, you must use the IBM Marketing Software reporting feature to view standard eMessage performance reports.

Verifying that the Campaign listener is running

The Campaign listener must be running before users can work with any Campaign features. The listener automatically creates a separate unica_acsvr process for each login and each active flowchart. For example, if one user logs in and then opens a flowchart, the listener creates two instances of unica acsvr.exe.

Use the following procedure to verify that the Campaign listener is running.

- 1. Use the appropriate procedure for your operating system:
 - In Windows, look for unica_aclsnr.exe on the **Processes** tab of the Windows Task Manager.
 - In UNIX, use the ps command to look for the Campaign server, as in the following example: ps -ef | grep unica_aclsnr.
- 2. If the listener is not running, restart it:
 - In Windows, run the cmpServer.bat script that is in the bin directory under your Campaign installation.
 - In UNIX, enter the following command at the system prompt: rc.unica_ac start

For important details about running the listener, including how to start it automatically, see the *IBM Campaign Administrator's Guide*.

Setting up the Campaign system user

Set up the Campaign system user to directly access databases. For multiple partitions in Campaign, create a system user for each partition.

A system user is a IBM Marketing Software user account that is configured for use by IBM applications.

To avoid presenting users with repeated prompts for login credentials you can associate a system user with one or more data sources. Each data source specifies a user name and password. This allows you to provide a user name and password to access a database or other protected resource by referencing the data source. By adding multiple data sources to the configuration of the system user account, you can allow the system user to access multiple databases.

In Campaign, the system user holds login credentials for accessing system tables and other data sources.

Use an existing or new IBM Marketing Software user account to save credentials for the data sources described here.

You set up IBM Marketing Software users and assign user data sources in the **Settings > Users** area of IBM Marketing Software. See the online help in that section for instructions on how to do this.

Set up a user account to hold credentials for the following data sources.

- Campaign system tables (UA_SYSTEM_TABLES)
- All customer (user) tables

On UNIX, for the **Alternate Login** attribute of the system user, enter the UNIX account of a user in a group that shares privileges with the UNIX users of Campaign.

Note: If you have multiple partitions, each partition must have its own system user. The system user cannot be the same across partitions.

Adding data source properties on the Configuration page

Use the appropriate data source template to add data source properties on the Configuration page for each Campaign data source.

The Campaign installer imports the template for the database type that you specified for the Marketing Platform database when you ran the IBM installer.

If you need other data source templates for additional database types, you must import them manually using the Marketing Platform configTool utility. You can import as many templates as you need, to correspond to each different type of database you have.

For example, suppose your installation of Marketing Platform and Campaign used the following databases:

- Oracle system tables
- DB2 customer (user) tables
- DB2 additional customer (user) tables

In this case, you would import the DB2Template.xml template for the two sets of customer (user) tables.

If your Marketing Platform and Campaign system tables databases are of the same database type, the installer automatically imports the template that is used for the system tables; in this example, it imports the Oracle template.

For instructions, see "Importing data source templates" on page 67.

You create a new category from the template, which creates a new set of data source configuration properties. Create as many new categories as needed, one for each data source of that type. In the example above, you would use the Oracle template to create one new category and the DB2 template to create two new categories. See "Duplicating a data source template" on page 67.

After you add the data source properties, set the data source configuration properties in the categories you created from the templates.

For instructions, see "Data source properties" on page 68.

Importing data source templates

The Campaign system tables data source (UA_SYSTEM_TABLES) is supported only on Oracle, DB2, and SQLServer. Import the data source templates for the user tables by using the **configTool** utility to support the database types that are not supported for the Campaign system tables.

The Campaign data source templates are located in the conf directory under your Campaign installation.

To import and export templates, you use the Marketing Platform configTool utility, located in the tools/bin directory under your Marketing Platform installation. If you are not familiar with configTool, see "configTool" on page 89 for details on performing this task.

Here is an example of the command you would use to import the Oracle template into the default partition (Windows environment).

configTool -i -p "Campaign|partitions|partition1|dataSources" -f
full_path_to_directory_containing_your_Oracle_template\OracleTemplate.xml

Duplicating a data source template

Duplicate the data source templates to create a new set of configuration properties in the data source category.

- 1. On the Configuration page, navigate to the data source template you want to duplicate.
 - Unlike other categories, template category labels are in italics and enclosed in parentheses.
- 2. Click the data source template.
 - The Create category from Template page displays.
- 3. Enter a name in the **New category name** field (required).

Note: The data source category name for the Campaign system tables MUST be UA_SYSTEM_TABLES.

- 4. If desired, edit properties within the new category. You can also do this later.
- 5. Click Save and Finish.

The new category appears in the navigation tree.

Campaign configuration properties

You must specify configuration properties on the Configuration page for a basic installation of Campaign. Additionally, you can use the Configuration page to specify the properties that perform important functions that you can optionally adjust.

Data source properties

The following table provides information about the properties that you must specify for each Campaign data source:

Table 17. Properties for each Campaign data source

Property name	Description
ASMUserForDBCredentials	This property must be the same user you already created as the Campaign system user in "Setting up the Campaign system user" on page 65.
DSN	For SQL server, set this property to the DSN (data source name) you created. For Oracle and DB2, set this property to the database name or the SID (service) name.
Jnd i Name	Set this property to the JNDI you created in your application server to connect to this specific data source.
SystemTableSchema	Not required for SQL server. For other data sources, set this property to the user of the database to which you are trying to connect.
OwnerForTableDisplay	Not required for SQL server. For other data sources, set this property to the user of the database to which you are trying to connect.

The data sources are the Campaign system table database and any customer (user) databases you plan to use with Campaign.

Note: The data source category name for the Campaign system tables **must** be UA_SYSTEM_TABLES.

For details on setting the values, see the context help for these properties or the *IBM Marketing Platform Administrator's Guide*.

In addition to creating and setting data source properties, you must set the following properties on the Configuration page for a basic installation of Campaign.

- Campaign > unicaACListener > serverHost
- Campaign > unicaACListener > serverPort
- For the default partition, set values as desired in the categories under Campaign > partitions > partition1.

When you change a property, you must restart the Campaign listener for the changes to take effect.

Mapping user tables in Campaign

Mapping user tables is the process of making external data sources accessible in Campaign. A typical user table contains information about your company's customers, prospects, or products. The data source can be a database table or ASCII flat file. You must map any data sources that you configured to make that data accessible to processes in flowcharts.

For instructions on how to map user tables, see the Campaign Administrator's Guide.

Note: User tables are different from system tables. Most Campaign system tables are mapped automatically during initial installation and configuration if you use the system table data source name UA_SYSTEM_TABLES. If a connection issue forces you to map system tables manually, you must log out of Campaign and log in again after you map the tables.

Verifying the Campaign installation

If you performed all of the steps to install and configure Campaign, deploy the Campaign web application, and configure Campaign after deployment, you are ready to verify your installation.

If you have not already done so, log in to IBM Marketing Software as a user that exists in the Campaign Administrators role (such as asm_admin). In **Settings** > **Users**, assign at least one security role (for example, Global Policy/Admin) to the new user. After the new user is assigned the role, you can log in to Campaign as that new user.

Use the following procedure to verify the installation.

- 1. Log in to IBM Marketing Software.
- 2. Verify that all system tables exist in the **Settings > Campaign Settings > Manage Table Mappings** window.
- 3. Create a campaign and create a flowchart in that campaign.

Setting properties for integration with IBM Marketing Software products

Campaign integrates with various IBM applications. If required, you can specify configuration properties to set up an integration between Campaign and other IBM products.

Additional configuration for enhanced security

The procedures in this section describe some additional configurations in the web application server. They are optional, but you might want to perform them for enhanced security.

Disabling the X-Powered-By flag

If your organization is concerned that the X-Powered-By flag in the header variable is a security risk, you can disable it using this procedure.

- 1. If you are using WebLogic, in the administration console, under *domainName* > Configuration > Web Application, set X-Powered-By Header to X-Powered-By Header will not be sent.
- 2. If you are using WebSphere, perform the following steps.
 - a. In the WebSphere administration console, navigate toServers > Server
 Types > WebSphere application servers > server_name > Web Container
 Settings > Web container.
 - b. Under Additional Properties select Custom Properties.
 - c. On the Custom Properties page, click New.
 - d. On the Settings page, create a custom property named com.ibm.ws.webcontainer.disablexPoweredBy and set the value to false.
 - e. Click **Apply** or **OK**.

- f. Click Save on the console task bar to save your configuration changes.
- g. Restart the server.

Configuring a restrictive cookie path

In your web application server, you can restrict cookie access to a specific application for enhanced security. If not restricted, cookies are valid across all the deployed applications.

- 1. If you are using WebLogic, perform the following steps.
 - a. Extract the weblogic.xml file from the WAR or EAR package where you want to add the restrictive cookie path.
 - b. Add the following to the weblogic.xml file, where *context-path* is the context path for the deployed application. For IBM Marketing Software applications the context path is typically /unica.

```
<session-descriptor>
    <session-param>
        <param-name>CookiePath</param-name>
        <param-value>/context-path> </param-value>
        </session-param>
</session-descriptor>
```

- c. Rebuild the WAR or EAR file.
- 2. If you are using WebSphere, perform the following steps.
 - a. In the WebSphere administration console, navigate to the **Session Manager** > **Cookie** tab.
 - Set the Cookie Path to the context path of your application.
 For IBM Marketing Software applications the context path is typically /unica.

Starting the Campaign Advance search agent

You can use the Campaign Advance search agent to search for flowcharts that you have created in Campaign. You can search for flowcharts only if the Advanced search agent is running when the a flowchart is created or modified.

IBM Marketing Platform and IBM Campaign web applications must be deployed and running before you start the Campaign Advance search agent.

To start the Campaign Advance search agent manually, complete the following steps:

1. For Windows, go to the bin directory under your Campaign installation and run advSrchAgent.bat.

The advSrchAgent.bat file keeps running at the prompt.

2. For Unix, go to the bin directory under your Campaign installation and run advSrchAgent.sh.

The advSrchAgent.sh file keeps running at the prompt.

For a Unix operating system, run the following command to start the Campaign Advance search agent.

```
./advSrchAgent.sh partition1
Usage:
./advSrchAgent.sh <start | stop> <partition_name> [cluster_home] [-u <user_name>] [-p <password>]
Where:
<start | stop> : Start or stop the agent.
<partition_name> : Name of the partition from which flowchart files are to be exported.
```

[cluster_home] : Home directory of clustered environment, if clustering is enabled.
[-u <user_name>] : User name for user who has read access to all flowchart files in the partition
[-p <password>] : Password of the user specified

Chapter 8. Configuring multiple partitions for Campaign

In the Campaign family of products, partitions provide a way to secure the data that is associated with different groups of users. When you configure Campaign or a related IBM Marketing Software application to operate with multiple partitions, users can see each partition as a separate instance of the application. There is no indication that other partitions exist on the same computer.

How multiple partitions work

For the IBM Marketing Software applications that operate with Campaign, you can configure the application within the partitions where you have configured an instance of Campaign. Application users within each partition can access the Campaign functions, data, and customer tables that are configured for Campaign in the same partition.

Partition benefits

Multiple partitions are useful for setting up strong security between groups of users, because each partition has its own set of Campaign system tables. Multiple partitions cannot be used when groups of users must share data.

Each partition has its own set of configuration settings, and Campaign can be customized for each group of users. However, all partitions share the same installation binaries. With the same binaries for all partitions, you can minimize the installation and upgrade efforts for multiple partitions.

Partition user assignment

Access to partitions is managed through membership in Marketing Platform groups.

With the exception of the partition superuser (platform_admin), each IBM user can belong to one partition. A user who requires access to multiple partitions must have a separate IBM user account for each partition.

If there is only one Campaign partition, users do not have to be explicitly assigned to that partition to have access to Campaign.

Partition data access

In a multi-partition configuration, partitions have the following security characteristics:

- A user cannot access a partition if the user is not a member of a group that is assigned to a partition.
- A user of one partition cannot view or change data in another partition.
- Users cannot navigate the Campaign file system above the root directory of their partition from the browse dialog boxes in Campaign. For example, if two partitions, named partition1 and partition2 exist, and you belong to the group that is associated with partition1, you cannot navigate the directory structure for partition2 from a dialog box.

Setting up multiple partitions

Configure multiple partitions in Campaign to isolate and secure data for different groups of Campaign users. As each partition has its own set of configuration properties, you can customize Campaign for each group of users.

Before you configure additional partitions in Campaign, complete the following tasks for each partition that you are configuring:

- 1. Create database or schema for the Campaign system tables
- 2. Create ODBC or native connections
- 3. Create JDBC connections in the web application server

Complete the following tasks to set up multiple partitions for Campaign:

- 1. Create the system tables database and any other data sources required for your partitions. Then configure the JDBC and ODBC or native connections required to access your data sources.
- 2. For each partition, create a different schema in your database to hold the system tables. Use the database-specific scripts packaged with Campaign to create and populate the system tables.
- 3. Complete the following tasks to create a directory structure for each additional partition:

Note: Save a clean copy of the original partition1 directory to serve as a backup.

- a. In the partitions directory under your Campaign installation, create a duplicate of the default partition1 directory for each partition that you are adding, ensuring that you include all subdirectories.
- b. Name each partition directory with a unique name. Use these exact same names for the partitions when you later create their configuration trees on the Configurations page. If you want to create a second partition and created the directory named Campaign/partitions/partition2, when you create the configuration tree on the Configurations page, you must use the name "partition2" to identify this partition.
- c. Delete any files that exist in the duplicate partition subdirectories.
- 4. Complete the following tasks to use the **partitionTool** utility with the **-s** option to clone the default partition:

Note: If you decide not to use this option, you must stop the web application server where Marketing Platform is deployed before performing this procedure.

- a. Set the JAVA_HOME environment variable, either in the setenv script located in the tools/bin directory of your Marketing Platform installation, or in the command line window in which you run the partitionTool utility.
- b. Open a command line window and run the utility from the tools/bin directory under your Marketing Platform installation. Use the appropriate command and options (as described in the Marketing Platform Administrator's Guide) to achieve your desired results. partitionTool -c -s partition1 -n partition2
- c. Repeat this procedure for each new partition you need to create.
- d. When you are finished, stop and restart the application server where Marketing Platform is deployed to see the groups that were created.

Note: For complete information on using this utility, see "partitionTool" on page 95.

- 5. Complete the following tasks to create the partition structure on the Configuration page by using the New partitionTemplate for each new partition:
 - a. On the Configuration page, navigate to Campaign > partitions and click (partitionTemplate).

If you do not see the *(partitionTemplate)* property in the list, use the configTool utility to import the partition template, using a command similar to the following:

```
configTool -i -p "Affinium|Campaign|partitions"
  -f <CAMPAIGN_HOME>/conf/partitionTemplate.xml
```

Replace *CAMPAIGN_HOME* with the actual path to your Campaign installation.

The configTool utility is found in the tools directory under your IBM Marketing Platform installation. See the *IBM Marketing Platform Administrator's Guide* for information on using this utility. In the right pane, you see the partitionTemplate pane with an empty **New category name** field.

- b. Enter the name for the new partition, using the same name that you used when creating the partition's directory structure in the file system in "Setting up multiple partitions" on page 74.
- c. Click **Save Changes**. You see the new partition structure, with the same categories and properties as in the partition template.

Partition superuser

To administer security across all users of Marketing Platform, a user account must exist that has access to all security settings and user accounts in the system.

By default, this user account is platform_admin. This user account does not belong to any one partition; instead, it has access to all user accounts in all partitions.

The IBM administrator can create additional users with the same level of access. To be a partition superuser, an account must have Admin access to the Marketing Platform and have full access to the Users, User Groups, and User Permissions pages. The partition superuser does not require access to product-specific security pages, such as Campaign security pages.

Configuring data source properties for partitions

You must configure data source properties for each partition that you create. Use the appropriate data source template to create data source properties.

The Campaign installer imports the template for the database type that you specified for the Marketing Platform database when you ran the IBM installer.

If you need other data source templates for additional database types, you must import them manually using the Marketing Platform **configTool** utility. You can import as many templates as you need to correspond to each different type of database you have.

For example, suppose your installation of Marketing Platform and Campaign used the following databases:

- Oracle system tables
- DB2 customer (user) tables

• DB2 - additional customer (user) tables

In this case, you would import the DB2Template.xml template for the two sets of customer (user) tables.

If your Marketing Platform and Campaign system tables databases are of the same database type, the installer automatically imports the template used for the system tables; in this example, it imports the Oracle template.

Note: When you create a new partition, you must use the **configTool** utility to import the data source templates for the system tables and user tables.

For instructions, see "Importing data source templates" on page 67.

You create a new category from the template, which creates a new set of data source configuration properties. Create as many new categories as needed, one for each data source of that type. In the example above, you would use the Oracle template to create one new category and the DB2 template to create two new categories. See "Duplicating a data source template" on page 67.

After you add the data source properties, set the data source configuration properties in the categories you created from the templates.

For instructions, see "Campaign configuration properties" on page 67.

Complete the following tasks to configure data source properties for each partition:

- 1. Add data source configuration properties to the Configuration page for each Campaign data source by using the appropriate data source template. The Campaign installer imports the template for the database type that you specified for the Marketing Platform database when you ran the IBM installer. If you need other data source templates for additional database types, you must import them manually using the Marketing Platform configTool utility. You can import as many templates as you need, to correspond to each different type of database you have. For example, suppose your installation of Marketing Platform and Campaign used the following databases:
 - Oracle system tables
 - DB2 customer (user) tables
 - DB2 additional customer (user) tables

In this case, you would import the DB2Template.xml template for the two sets of customer (user) tables. If your Marketing Platform and Campaign system tables databases are of the same database type, the installer automatically imports the template used for the system tables; in this example, it imports the Oracle template. For instructions, see "Importing data source templates" on page 67.

- 2. Create a new category from the template, which creates a new set of data source configuration properties. Create as many new categories as needed, one for each data source of that type. In the example above, you would use the Oracle template to create one new category and the DB2 template to create two new categories. See "Duplicating a data source template" on page 67.
- 3. Set the data source configuration properties for each Campaign data source. See "Campaign configuration properties" on page 67 for more information.

Setting up system users for Campaign

You can associate a system user with one or more Marketing Platform data sources to avoid presenting users with repeated prompts for login credentials. Each data source specifies a user name and password. You can provide a user name and password to access a database or other protected resources by referencing the data source. By adding multiple data sources to the configuration of the system user account, you can allow the system user to access multiple databases.

IBM Marketing Software applications might require a system user account configured with the following attributes:

- Login credentials for accessing system tables or other data sources.
- Specific permissions to create, modify, and delete objects within the system.

For more information about setting up a new user and assigning a data source to a user, see the *IBM Marketing Platform Administrator's Guide*.

Complete the following actions to set up system users for Campaign:

- 1. Use an existing or a new user account to save credentials for the following data sources:
 - Campaign system tables
 - All customer (user) tables
- 2. On UNIX, for the **Alternate Login** attribute of the system user, enter the UNIX name for a user in a group that shares privileges with the UNIX users of Campaign.

Note: If you have multiple partitions, you must create a system user for each partition.

Using IBM Cognos Reports for multiple partitions

If you want to use IBM Cognos® Reports for multiple partitions in Campaign, eMessage, or Interact, you must configure IBM Cognos reports packages for each partition.

For instructions, see the *IBM Marketing Software Reports Installation and Configuration Guide*.

Assigning roles, permissions, and groups for partitions

Before you can use the partitions that you have configured for Campaign, you must assign roles to the user with administrator role in each partition. You must also assign a group to each partition.

Use the **partitionTool** utility to create a default admin user for each partition that you create.

Assign roles to each partition Admin user - The partitionTool utility creates a default Admin user for each partition you create. On the Users page, assign at least one security role (for example, Global Policy/Admin) to your new user. Once the new user has been assigned the role, you can log into the Campaign partition as that new user.

If you plan to enable IBM eMessage in multiple Campaign partitions, you must configure a corresponding eMessage partition for each Campaign partition. For

more information about creating additional partitions for eMessage, see Chapter 9, "Configuring multiple partitions in eMessage," on page 79.

Chapter 9. Configuring multiple partitions in eMessage

Configure multiple partitions in eMessage to isolate and secure data for different groups of eMessage users. As each partition has its own set of configuration properties, you can customize eMessage for each group of users.

Installing eMessage creates a default partition for eMessage in the Marketing Platform. You can configure more partitions for eMessage. Each partition that you create for eMessage operates in conjunction with a partition created for Campaign.

Note: To configure multiple partitions in eMessage you must configure corresponding partitions in Campaign.

Adding new partitions for eMessage requires making changes in the Marketing Platform configurations for eMessage and Campaign.

Important: After you change the eMessage and Campaign configurations, you must restart the web application server that hosts Campaign and restart the Response and Contact Tracker (RCT). You might also need to restart the Campaign listener.

Be sure to back up your existing configurations before you make changes.

Partitions for eMessage: Overview

Creating partitions for eMessage allows you to isolate and secure data for different groups of users. Each partition appears to users as a separate instance of eMessage, with no indication that other partitions exist on the same system. Because each partition has its own set of configuration properties, you can customize eMessage for each group of users.

Users within each partition can access only those functions, data, and customer tables configured for the partition. For example, if you create partitions named partition1 and partition2, eMessage users working in partition1 can select email recipients from customer tables configured in partition1, but not in partition2. IBM does not recommend creating multiple partitions if users need to share data.

When you work with multiple partitions, you should understand characteristics that are unique to partitions for eMessage and how partitions for eMessage relate to partitions for Campaign. You should also be familiar with the workflow for creating and configuring multiple partitions for eMessage.

Characteristics of partitions for eMessage

Note the following when you create and configure new partitions for eMessage.

- You create partitions for eMessage differently than you do for Campaign.
 You create new partitions for eMessage using a partition template available in the eMessage configuration properties in Marketing Platform.
- The name of each eMessage partition must exactly match the name of its corresponding Campaign partition.
- Each partition that you create for eMessage must be able to connect to IBM Marketing Software Hosted Services.

You must request a separate IBM Marketing Software Hosted Services account for each partition. IBM will provide a user name and password connected to the account. You must configure a Marketing Platform data source that can provide these access credentials automatically when eMessage connects to IBM Marketing Software Hosted Services.

For more information about how to request an account, see the *IBM eMessage Startup and Administrator's Guide*.

Relationship to partitions in Campaign

Each partition in eMessage operates in conjunction with a specific partition created in the Marketing Platform for Campaign. The Campaign partition provides the following.

- · Campaign schema that contains the eMessage system tables
- File structure for Campaign in the partition, including directories used by eMessage to create and process recipient lists
- Configuration properties associated with creating recipient lists and enabling eMessage within the partition

Because eMessage operates with Campaign within a specific partition, the eMessage and Campaign partition structures must specify the same name. The partition names must match exactly.

Roadmap for configuring multiple partitions in eMessage

To create a partition in eMessage, use the exact same name as the partition in Campaign that exists in the Marketing Platform configurations.

Before you create a new partition for eMessage, confirm that you have satisfied all the eMessage prerequisites for the partition in Campaign and eMessage.

Complete the following steps to create a new partition for eMessage.

- 1. "Creating a new partition for eMessage"

Creating a new partition for eMessage

Installing eMessage creates a default partition for eMessage in Marketing Platform. You can create multiple partitions for eMessage to isolate and secure data for different groups of users.

Before you create and configure partitions for eMessage, you must meet the following requirements for eMessage and Campaign:

• Before you create multiple partitions in eMessage, complete the following tasks for eMessage:

- Contact IBM Support to request an account and credentials for each partition.
 Each partition requires a separate IBM Marketing Software Hosted Services account and access credentials. For more information, see the IBM Startup and Administrator's Guide.
- Create a system user that can access the eMessage system tables that you will create in the Campaign schema for the partition.
 - You can update the system user that you created for the Campaign partition so that it can also access the eMessage system tables.
- Before you create multiple partitions in eMessage, complete the following tasks in Campaign:
 - Create a partition in Campaign to operate with the partition that you are creating for eMessage. Note the name of the partition.
 - Create Campaign system tables in the Campaign partition.
 - Configure a system user to access the system tables in the partition.
 If you have multiple partitions, each partition must have its own system user.
 The system user cannot be the same across partitions.

The IBM installer registers the eMessage configuration properties and a default partition during initial installation. The default partition includes a template that you can copy to create additional partitions.

Complete the following actions to create a new partition for eMessage:

- 1. Navigate to eMessage > partitions > (partition) and duplicate the partition template.
- 2. Name the new partition.

Note: eMessage does not support deleting a partition after you have created it.

Identifying the partition template

The Configuration page displays the eMessage partition template in the navigation tree for the default partition. You can identify the partition template in the tree because its label is in italics and enclosed in parentheses.

Naming the new partition

The following restrictions apply when you name a new partition.

- The name must be unique among categories that are siblings in the tree (that is, among categories that share the same parent category).
- The partition name may not start with a period. Also, the following characters are not allowed in partition names.

Note: Because eMessage operates with Campaign within a specific partition, the partitions for eMessage and Campaign must specify the same partition name.

Preparing eMessage system tables for the partition

For each partition that you create for eMessage, you must create, populate and configure the eMessage system tables that are used by the partition in the Campaign schema.

Complete the following actions to prepare the eMessage system tables for a partition:

- 1. Create the eMessage system tables. In your database client, run the SQL scripts for *creating* system tables against the Campaign database.
- 2. Populate the tables that you created. Use the database client to run the scripts for *populating* tables against the Campaign database. For more information about the SQL scripts, see the reference table for script names and locations at "Creating and populating the eMessage system tables manually" on page 52.
- 3. Set the following configuration properties in the eMessage configuration for the partition, specifying the user name and platform data source that you configured for the partition's Campaign system user:
 - eMessage > partitions > partition [n] < dataSources > systemTables > asmUserForDBCredentials
 - eMessage > partitions > partition [n] < dataSources > systemTables > amDataSourceForDBCredentials

eMessage accesses the partition's system tables through a system user configured in Marketing Platform. A Marketing Platform data source added to the system user provides the required access credentials. Because the eMessage system tables exist in the Campaign schema for the partition, you can use the system user that you created to access the Campaign schema to access the partition's eMessage system tables.

- 4. Update the following properties in the partition's configuration properties:
 - eMessage > partitions > partition [n] < dataSources > systemTables > type
 - eMessage > partitions > partition [n] < dataSources > systemTables > schemaName
 - eMessage > partitions > partition [n] < dataSources > systemTables > jdbcBatchSize
 - eMessage > partitions > partition [n] < dataSources > systemTables > jdbcClassName
 - eMessage > partitions > partition [n] < dataSources > systemTables > jdbcURI

See the Marketing Platform online help for each property to learn more about setting the configuration properties. For additional information about these configuration properties and configuring eMessage, see the *IBM eMessage Startup and Administrator's Guide*.

Creating and populating the eMessage system tables manually

For eMessage, you must create additional system tables in the Campaign schema and then populate the tables with initial data. The Campaign installer automatically creates and populates the eMessage system tables in the Campaign schema if you select the option to create system tables automatically. However, if you do not select the option, you must create and populate the eMessage system tables manually.

Use your database client to run the appropriate script against the Campaign database.

Note: The eMessage installation directory is a subfolder within the Campaign directory.

Scripts for creating eMessage tables

IBM provides the ace_op_systab scripts for creating eMessage tables in your local environment.

If your Campaign system tables are configured for Unicode, find the appropriate script in the ddl/unicode directory under your eMessage installation.

If your Campaign system tables are not configured for Unicode, use the non-Unicode scripts in the ddl directory under your eMessage installation. Use the following table to see the scripts that you must use:

Table 18. Scripts for creating eMessage tables

Data source type	Script name	
IBM DB2	ace_op_systab_db2.sql	
	The user tablespace and system temporary tablespace where the system tables reside must each have a page size of 16K or greater.	
Microsoft SQL Server	ace_op_systab_sqlsvr.sql	
Oracle	ace_op_systab_ora.sql	

Scripts for populating eMessage tables

IBM provides the ace_op_populate_systab scripts for populating the eMessage tables in your local environment.

The populate scripts are stored in the ddl directory of your eMessage installation. IBM provides only one version of the populate scripts because you can use them for either Unicode or non-Unicode tables.

Note: The eMessage installation directory is a subfolder within the Campaign directory.

Use the following table to see the scripts that you must use:

Table 19. Scripts for populating eMessage tables

Data source type	Script name
IBM DB2	ace_op_populate_systab_db2.sql
Microsoft SQL Server	ace_op_populate_systab_sqlsvr.sql
Oracle	ace_op_populate_systab_ora.sql

Configuring a system user to access IBM Marketing Software Hosted Services

eMessage components must be able to access the IBM Marketing Software Hosted Services without requiring manual entry of login credentials. To establish automatic login, define a system user in Marketing Platform that can provide the required access credentials.

To simplify user administration and troubleshooting, you can modify an existing system user to access hosted services and local system tables. You can configure a single system user to provide credentials for multiple systems. For example, modifying the configuration of the Campaign system user creates a single user that can automatically access IBM Marketing Software Hosted Services and the eMessage system tables in the Campaign schema.

The credentials required to access IBM Marketing Software Hosted Services are the user name and password that IBM provides for your hosted messaging account. The credentials that you use depend on whether you are connecting to the IBM US data center or the data center that IBM maintains in the United Kingdom. Consult with IBM to determine which data center you use.

For specific information about how to configure a system user to communicate with IBM Marketing Software Hosted Services, see the *IBM eMessage Startup and Administrator's Guide*.

For general information about how to create system users and data sources, see the *IBM Marketing Platform Administrator's Guide*.

Configuring partition access to IBM Marketing Software Hosted Services

IBM eMessage components in the partition must be allowed to automatically provide valid login credentials when attempting to communicate with IBM Marketing Software Hosted Services. To do this, you must add the IBM Marketing Software Hosted Services login credentials to a Marketing Platform user. This user becomes the eMessage system user.

You can add the platform data source containing the IBM Marketing Software Hosted Services credentials to the eMessage system user. This user can be the same system user that accesses the Campaign system tables in the partition.

The steps for configuring system users for a partition are the same as those followed during the initial eMessage installation, which created the first partition. For details about how to add IBM Marketing Software Hosted Services login credentials to a system user, see the *IBM eMessage Startup and Administrator's Guide*.

The credentials required to access IBM Marketing Software Hosted Services are the user name and password that IBM provided during the initial startup process.

Important: For each additional partition, you must request a separate user name and password from IBM.

Enabling eMessage in Campaign for the new partition

To allow users of the new eMessage partition to access the eMessage features in Campaign, enable eMessage in the Campaign partition by updating the eMessageInstalled configuration property for the corresponding Campaign partition.

For example, the eMessage mailing tab does not appear in the Campaign interface until you enable eMessage in the Campaign configuration.

You enable eMessage in the partition by updating the eMessageInstalled configuration property for the corresponding Campaign partition.

In the Marketing Platform configurations, navigate to Campaign | partitions | partition[n] | server | internal and set the eMessageInstalled property to yes.

Specifying the Recipient List Uploader location for eMessage

For each partition where you enable eMessage, specify the location of the Recipient List Uploader (RLU). The RLU uploads the output list tables data and associated metadata to the remote services hosted by IBM.

During initial installation, the IBM installer automatically adds the location of the RLU to the configuration for default partition (partition1). However, when you add new partitions to your environment, you must manually configure all new partitions to reference the correct location. Because there is only one RLU for each eMessage installation, all partitions access the same plugin file in the local file system of the machine that hosts the Campaign web application.

- In the configuration for partition1 in your Campaign installation, navigate to Campaign > partitions > partition1 > eMessage > eMessagePluginJarFile.
 The value for this property is the full path to the plugin file (emessageplugin.jar) that operates as the RLU.

 For example: C:\IBM\Unica\eMessage\plugin\emessageplugin.jar
- 2. Copy the value for the eMessagePluginJarFile property.
- 3. Navigate to the eMessagePluginJarFile for the new partition and enter the path you copied from **partition1**.
 - All partitions must use the same location for the RLU.

Restarting system components after configuring eMessage

After you change the eMessage and Campaign configurations, you must restart the Campaign web application server, the Response and Contact Tracker (RCT), and the Campaign listener.

- Restart the web application server for Campaign.
 For instructions, see the documentation for your web application server.
 To verify that the server has started, log in to your IBM Marketing Software installation, access Campaign, and confirm that you can open an existing mailing.
- 2. Restart the Response and Contact Tracker (RCT).

 To restart the RCT manually, run the rct script in the bin directory under your eMessage installation, as follows: rct start

If RCT is configured to run as a service, restart the RCT service. The first time that you restart the RCT as a service, you must manually restart the RCT afterward.

For more information, see "eMessage Response and Contact Tracker (RCT) script" on page 101.

- 3. Restart the Campaign listener:
 - On Windows, run the cmpServer.bat file in the bin directory under your Campaign installation.
 - On UNIX, run the following command as root: ./rc.unica_ac start

Testing eMessage partition configuration and connections

Use the scripts that are provided by eMessage to verify the partition configuration and its connection to IBM Marketing Software Hosted Services. You must also confirm if you can access the mailing interface from the partition.

Important: Before you begin, if you have changed the Campaign or eMessage configurations, confirm that you have restarted the web application server that hosts Campaign and that you have restarted the Response and Contact Tracker.

For more information on how to test the partition, see the *IBM eMessage Startup* and Administrator's Guide.

Chapter 10. Marketing Platform utilities

This section provides an overview of the Marketing Platform utilities, including some details that apply to all of the utilities and which are not included in the individual utility descriptions.

Location of utilities

Marketing Platform utilities are located in the tools/bin directory under your Marketing Platform installation.

List and descriptions of utilities

The Marketing Platform provides the following utilities.

- "alertConfigTool" on page 89 registers alerts and configurations for IBM Marketing Software products
- "configTool" on page 89 imports, exports, and deletes configuration settings, including product registrations
- "datafilteringScriptTool" on page 93 creates data filters
- "encryptPasswords" on page 94 encrypts and stores passwords
- "partitionTool" on page 95 creates database entries for partitions
- "populateDb" on page 97 populates the Marketing Platform database
- "restoreAccess" on page 98 restores a user with the platformAdminRole role
- "scheduler_console_client" on page 100 lists or starts IBM Marketing Software Scheduler jobs that are configured to listen for a trigger.

Prerequisites for running Marketing Platform utilities

The following are prerequisites for running all Marketing Platform utilities.

- Run all utilities from the directory where they are located (by default, the tools/bin directory under your Marketing Platform installation).
- On UNIX, the best practice is to run the utilities with the same user account that runs the application server on which Marketing Platform is deployed. If you run a utility with a different user account, adjust the permissions on the platform.log file to allow that user account to write to it. If you do not adjust permissions, the utility is not able to write to the log file and you might see some error messages, although the tool should still function correctly.

Authentication of utilities

Utilities such as configTool and other IBM Marketing Software back end utilities are designed to be used by system administrators and require physical access to the host servers for them to be invoked. For this reason, authentication for these utilities has been designed to be independent of the UI authentication mechanism. Access to these utilities is available to users with Marketing Platform administrator privileges. Access to these utilities is expected to be locally defined in Marketing Platform and authenticated against the same.

Troubleshooting connection issues

All of the Marketing Platform utilities except encryptPasswords interact with the Marketing Platform system tables. To connect to the system table database, these utilities use the following connection information, which is set by the installer using information provided when the Marketing Platform was installed. This information is stored in the jdbc.properties file, located in the tools/bin directory under your Marketing Platform installation.

- JDBC driver name
- JDBC connection URL (which includes the host, port, and database name)
- · Data source login
- Data source password (encrypted)

In addition, these utilities rely on the JAVA_HOME environment variable, set either in the setenv script located in the tools/bin directory of your Marketing Platform installation, or on the command line. The Marketing Platform installer should have set this variable automatically in the setenv script, but it is a good practice to verify that the JAVA_HOME variable is set if you have a problem running a utility. The JDK must be the Sun version (not, for example, the JRockit JDK available with WebLogic).

Special characters

Characters that are designated as reserved characters in the operating system must be escaped. Consult your operating system documentation for a list of reserved characters and how to escape them.

Standard options in Marketing Platform utilities

The following options are available in all Marketing Platform utilities.

-1 logLevel

Set the level of log information displayed in the console. Options are high, medium, and low. The default is low.

-L

Set the locale for console messages. The default locale is en_US. The available option values are determined by the languages into which the Marketing Platform has been translated. Specify the locale using the ICU locale ID according to ISO 639-1 and ISO 3166.

-h

Display a brief usage message in the console.

-m

Display the manual page for this utility in the console.

-۷

Display more execution details in the console.

alertConfigTool

Notification types are specific to the various IBM Marketing Software products. Use the alertConfigTool utility to register the notification types when the installer has not done this automatically during installation or upgrade.

Syntax

alertConfigTool -i -f importFile

Commands

-i -f importFile

Import alert and notification types from a specified XML file.

Example

• Import alert and notification types from a file named Platform_alerts_configuration.xml located in the tools\bin directory under the Marketing Platform installation.

```
alertConfigTool -i -f Platform_alerts_configuration.xml
```

configTool

The properties and values on the Configuration page are stored in the Marketing Platform system tables. You can use the configTool utility to import and export configuration settings to and from the system tables.

When to use configTool

You might want to use configTool for the following reasons.

- To import partition and data source templates that are supplied with Campaign, which you can then modify and duplicate by using the Configuration page.
- To register (import configuration properties for) IBM Marketing Software products, if the product installer is unable to add the properties to the database automatically.
- To export an XML version of configuration settings for backup or to import into a different installation of IBM Marketing Software.
- To delete categories that do not have the **Delete Category** link. You do this by using configTool to export your configuration, then manually deleting the XML that creates the category, and by using configTool to import the edited XML.

Important: This utility modifies the usm_configuration and usm_configuration_values tables in the Marketing Platform system table database, which contains the configuration properties and their values. For best results, either create backup copies of these tables, or export your existing configurations by using configTool and back up the resulting file so you have a way to restore your configuration if you make an error when you use configTool to import.

Syntax

```
configTool -d -p "elementPath" [-o]
configTool -i -p "parent ElementPath" -f importFile [-o]
```

```
configTool -x -p "elementPath" -f exportFile
configTool -vp -p "elementPath" -f importFile [-d]
configTool -r productName -f registrationFile [-o] configTool -u
productName
```

Commands

-d -p "elementPath" [o]

Delete configuration properties and their settings, specifying a path in the configuration property hierarchy.

The element path must use the internal names of categories and properties. You can obtain them by going to the Configuration page, selecting the wanted category or property, and looking at the path that is displayed in parentheses in the right pane. Delimit a path in the configuration property hierarchy by using the | character, and surround the path with double quotation marks.

Note the following.

- Only categories and properties within an application can be deleted by using this command, not whole applications. Use the -u command to unregister a whole application.
- To delete categories that do not have the **Delete Category** link on the Configuration page, use the -o option.

When you use -d with the -vp command, the configTool deletes any child nodes in the path you specify if those nodes are not included in the XML file you specify.

-i -p "parentElementPath" -f importFile [o]

Import configuration properties and their settings from a specified XML file.

To import, you specify a path to the parent element under which you want to import your categories. The configTool utility imports properties under the category you specify in the path.

You can add categories at any level below the top level, but you cannot add a category at same level as the top category.

The parent element path must use the internal names of categories and properties. You can obtain them by going to the Configuration page, selecting the required category or property, and looking at the path that is displayed in parentheses in the right pane. Delimit a path in the configuration property hierarchy by using the | character, and surround the path with double quotation marks.

You can specify an import file location relative to the tools/bin directory or you can specify a full directory path. If you specify a relative path or no path, configTool first looks for the file relative to the tools/bin directory.

By default, this command does not overwrite an existing category, but you can use the -o option to force an overwrite.

```
-x -p "elementPath" -f exportFile
```

Export configuration properties and their settings to an XML file with a specified name.

You can export all configuration properties or limit the export to a specific category by specifying a path in the configuration property hierarchy.

The element path must use the internal names of categories and properties, which you can obtain by going to the Configuration page, selecting the wanted category or property, and looking at the path that is displayed in parentheses in the right pane. Delimit a path in the configuration property hierarchy by using the | character, and surround the path with double quotation marks.

You can specify an export file location relative to the current directory or you can specify a full directory path. If the file specification does not contain a separator (/ on UNIX, / or \ on Windows), configTool writes the file to the tools/bin directory under your Marketing Platform installation. If you do not provide the xml extension, configTool adds it.

-vp -p "elementPath" -f importFile [-d]

This command is used mainly in manual upgrades, to import configuration properties. If you applied a fix pack that contains a new configuration property, and you then upgrade, importing a configuration file as part of a manual upgrade process can override values that were set when the fix pack was applied. The -vp command ensures that the import does not override previously set configuration values.

Important: After you use the configTool utility with the -vp option, you must restart the web application server on which Marketing Platform is deployed so the changes are applied.

When you use -d with the -vp command, the configTool deletes any child nodes in the path you specify if those nodes are not included in the XML file you specify.

-r productName -f registrationFile

Register the application. The registration file location can be relative to the tools/bin directory or can be a full path. By default, this command does not overwrite an existing configuration, but you can use the -o option to force an overwrite. The *productName* parameter must be one of those names that are listed above.

Note the following.

- When you use the -r command, the registration file must have <application> as the first tag in the XML.
 - Other files can be provided with your product that you can use to insert configuration properties into the Marketing Platform database. For these files, use the -i command. Only the file that has the <application> tag as the first tag can be used with the -r command.
- The registration file for the Marketing Platform is named Manager_config.xml, and the first tag is <Suite>. To register this file on a new installation, use the populateDb utility, or rerun the Marketing Platform installer as described in the IBM Marketing Platform Installation Guide.

• After the initial installation, to re-register products other than the Marketing Platform, use configTool with the -r command and -o to overwrite the existing properties.

The configTool utility uses product names as parameters with the commands that register and unregister products. With the 8.5.0 release of IBM Marketing Software, many product names changed. However, the names that are recognized by configTool did not change. The valid product names for use with configTool are listed below, along with the current names of the products.

Table 20. Product names for configTool registration and unregistration

Product name	Name used in configTool
Marketing Platform	Manager
Campaign	Campaign
Distributed Marketing	Collaborate
eMessage	emessage
Interact	interact
Contact Optimization	Optimize
Marketing Operations	Plan

Digital Analytics	Coremetrics

-u productName

Unregister an application that is specified by *productName*. You do not have to include a path to the product category; the product name is sufficient, and it is required. The process removes all properties and configuration settings for the product.

Options

-0

When used with -i or -r, it overwrites an existing category or product registration (node).

When used with -d, you can delete a category (node) that does not have the **Delete Category** link on the Configuration page.

Examples

- Import configuration settings from a file named Product_config.xml in the conf directory under the Marketing Platform installation.
 - configTool -i -p "Affinium" -f Product config.xml
- Import one of the supplied Campaign data source templates into the default Campaign partition, partition1. The example assumes that you placed the Oracle data source template, OracleTemplate.xml, in the tools/bin directory under the Marketing Platform installation.
 - configTool -i -p "Affinium|Campaign|partitions|partition1|dataSources" -f
 OracleTemplate.xml

- Export all configuration settings to a file named myConfig.xml in the D:\backups directory.
 - configTool -x -f D:\backups\myConfig.xml
- Export an existing Campaign partition (complete with data source entries), save it to a file named partitionTemplate.xml, and store it in the default tools/bin directory under the Marketing Platform installation.
 - configTool -x -p "Affinium|Campaign|partitions|partition1" -f
 partitionTemplate.xml
- Manually register an application named productName, by using a file named app_config.xml in the default tools/bin directory under the Marketing Platform installation, and force it to overwrite an existing registration of this application. configTool -r product Name -f app config.xml -o
- Unregister an application named productName. configTool -u productName

datafilteringScriptTool

The datafilteringScriptTool utility reads an XML file to populate the data filtering tables in the Marketing Platform system table database.

Depending on how you write the XML, you can use this utility in two ways.

- Using one set of XML elements, you can auto-generate data filters based on unique combinations of field values (one data filter for each unique combination).
- Using a slightly different set of XML elements, you can specify each data filter that the utility creates.

See IBM Marketing Platform the Administrator's Guide for information about creating the XML.

When to use datafilteringScriptTool

You must use datafilteringScriptTool when you create new data filters.

Prerequisites

The Marketing Platform must be deployed and running.

Using datafilteringScriptTool with SSL

When the Marketing Platform is deployed using one-way SSL you must modify the datafilteringScriptTool script to add the SSL options that perform handshaking. To modify the script, you must have the following information.

- · Truststore file name and path
- Truststore password

In a text editor, open the datafilteringScriptTool script (.bat or .sh) and find the lines that look like this (examples are Windows version).

:callexec

"%JAVA_HOME%\bin\java" -DUNICA_PLATFORM_HOME="%UNICA_PLATFORM_HOME%"

com.unica.management.client.datafiltering.tool.DataFilteringScriptTool %*

Edit these lines to look like this (new text is in **bold**). Substitute your truststore path and file name and truststore password for myTrustStore.jks and myPassword.

:callexec

```
SET SSL OPTIONS=-Djavax.net.ssl.keyStoreType="JKS"
```

-Djavax.net.ssl.trustStore="C:\security\myTrustStore.jks"

-Djavax.net.ssl.trustStorePassword=myPassword

"%JAVA_HOME%\bin\java" -DUNICA_PLATFORM_HOME="%UNICA_PLATFORM_HOME%"
%SSL OPTIONS%

com.unica.management.client.datafiltering.tool.DataFilteringScriptTool %*

Syntax

datafilteringScriptTool -r pathfile

Commands

-r path_file

Import data filter specifications from a specified XML file. If the file is not located in the tools/bin directory under your installation, provide a path and enclose the <code>path_file</code> parameter in double quotation marks.

Example

• Use a file named collaborateDataFilters.xml, located in the C:\unica\xml directory, to populate the data filter system tables.

datafilteringScriptTool -r "C:\unica\xml\collaborateDataFilters.xml"

encryptPasswords

The encryptPasswords utility is used to encrypt and store either of two passwords that Marketing Platform uses internally.

The two passwords that the utility can encrypt are as follows.

- The password that the Marketing Platform uses to access its system tables. The utility replaces an existing encrypted password (stored in the jdbc,properties file, located in the tools\bin directory under your Marketing Platform installation) with a new one.
- The keystore password used by the Marketing Platform when it is configured to
 use SSL with a certificate other than the default one supplied with the Marketing
 Platform or the web application server. The certificate can be either a self-signed
 certificate or a certificate from a certificate authority.

When to use encryptPasswords

Use encryptPasswords as for the following reasons.

• When you change the password of the account used to access your Marketing Platform system table database.

• When you have created a self-signed certificate or have obtained one from a certificate authority.

Prerequisites

- Before running encryptPasswords to encrypt and store a new database password, make a backup copy of the jdbc.properties file, located in the tools/bin directory under your Marketing Platform installation.
- Before running encryptPasswords to encrypt and store the keystore password, you must have created or obtained a digital certificate and know the keystore password.

Syntax

encryptPasswords -d databasePassword

encryptPasswords -k keystorePassword

Commands

-d databasePassword

Encrypt the database password.

-k keystorePassword

Encrypt the keystore password and store it in a file named pfile.

Examples

- When the Marketing Platformwas installed, the login for the system table
 database account was set to myLogin. Now, some time after installation, you have
 changed the password for this account to newPassword. Run encryptPasswords as
 follows to encrypt and store the database password.
 - encryptPasswords -d newPassword
- You are configuring an IBM Marketing Software application to use SSL and have created or obtained a digital certificate. Run encryptPasswords as follows to encrypt and store the keystore password.
 - encryptPasswords -k myPassword

partitionTool

Partitions are associated with Campaign policies and roles. These policies and roles and their partition associations are stored in the Marketing Platform system tables. The partitionTool utility seeds the Marketing Platform system tables with basic policy and role information for partitions.

When to use partitionTool

For each partition you create, you must use partitionTool to seed the Marketing Platform system tables with basic policy and role information.

See the installation guide appropriate for your version of Campaign for detailed instructions on setting up multiple partitions in Campaign.

Special characters and spaces

Any partition description or user, group, or partition name that contains spaces must be enclosed in double quotation marks.

Syntax

```
partitionTool -c -s sourcePartition -n newPartitionName [-u
admin_user_name] [-d partitionDescription] [-g groupName]
```

Commands

The following commands are available in the partitionTool utility.

-c

Replicates (clones) the policies and roles for an existing partition specified using the -s option, and uses the name specified using the -n option. Both of these options are required with c. This command does the following.

- Creates a new IBM Marketing Software user with the Admin role in both the Administrative Roles policy and the global policy in Campaign. The partition name you specify is automatically set as this user's password.
- Creates a new Marketing Platform group and makes the new Admin user a member of that group.
- Creates a new partition object.
- Replicates all the policies associated with the source partition and associates them with the new partition.
- For each replicated policy, replicates all roles associated with the policy.
- For each replicated role, maps all functions in the same way that they were mapped in the source role.
- Assigns the new Marketing Platform group to the last system-defined Admin role created during role replication. If you are cloning the default partition, partition1, this role is the default Administrative Role (Admin).

Options

-d partitionDescription

Optional, used with -c only. Specifies a description that appears in the output from the -list command. Must be 256 characters or less. Enclose in double quotation marks if the description contains spaces.

-g groupName

Optional, used with -c only. Specifies the name of the Marketing Platform Admin group that the utility creates. The name must be unique within this instance of Marketing Platform

If not defined, the name defaults to partition nameAdminGroup.

-n partitionName

Optional with -list, required with -c. Must be 32 characters or less.

When used with -list, specifies the partition whose information is listed.

When used with -c, specifies the name of the new partition, and the partition name you specify is used as the password for the Admin user. The partition name must match the name you gave the partition in when you configured it (using the partition template on the Configuration page).

-s sourcePartition

Required, used with -c only. The name of the source partition to be replicated.

-u adminUserName

Optional, used with -c only. Specifies the user name of the Admin user for the replicated partition. The name must be unique within this instance of Marketing Platform.

If not defined, the name defaults to partitionNameAdminUser.

The partition name is automatically set as this user's password.

Examples

- Create a partition with the following characteristics.
 - Cloned from partition1
 - Partition name is myPartition
 - Uses the default user name (myPartitionAdminUser) and password (myPartition)
 - Uses the default group name (myPartitionAdminGroup)
 - Description is "ClonedFromPartition1"

partitionTool -c -s partition1 -n myPartition -d "ClonedFromPartition1"

- Create a partition with the following characteristics.
 - Cloned from partition1
 - Partition name is partition2
 - Specifies user name of customerA with the automatically assigned password of partition2
 - Specifies group name of customerAGroup
 - Description is "PartitionForCustomerAGroup"

partitionTool -c -s partition1 -n partition2 -u customerA -g
customerAGroup -d "PartitionForCustomerAGroup"

populateDb

The populateDb utility inserts default (seed) data in the Marketing Platform system tables.

The IBM Marketing Software installer can populate the Marketing Platform system tables with default data for Marketing Platform and for Campaign. However, if your company policy does not permit the installer to change the database, or if the installer is unable to connect with the Marketing Platform system tables, you must insert default data in the Marketing Platform system tables using this utility.

For Campaign, this data includes security roles and permissions for the default partition. For Marketing Platform, this data includes default users and groups, and security roles and permissions for the default partition.

Syntax

populateDb -n productName

Commands

-n productName

Insert default data into the Marketing Platform system tables. Valid product names are Manager (for Marketing Platform) and Campaign (for Campaign).

Examples

- Insert Marketing Platform default data manually.
 populateDb -n Manager
- Insert Campaign default data manually. populateDb -n Campaign

restoreAccess

The restoreAccess utility allows you to restore access to Marketing Platform if all users with PlatformAdminRole privileges have been inadvertently locked out or if all ability to log in to the Marketing Platform has been lost.

When to use restoreAccess

You might want to use restoreAccess under the two circumstances described in this section.

PlatformAdminRole users disabled

It is possible that all users with PlatformAdminRole privileges in Marketing Platform might become disabled in the system. Here is an example of how the platform_admin user account might become disabled. Suppose you have only one user with PlatformAdminRole privileges (the platform_admin user). Assume the Maximum failed login attempts allowed property property in the **General I Password settings** category on the Configuration page is set to 3. Then suppose someone who is attempting to log in as platform_admin enters an incorrect password three times in a row. These failed login attempts cause the platform_admin account to become disabled in the system.

In that case, you can use restoreAccess to add a user with PlatformAdminRole privileges to the Marketing Platform system tables without accessing the web interface.

When you run restoreAccess in this way, the utility creates a user with the login name and password you specify, and with PlatformAdminRole privileges.

If the user login name you specify exists in Marketing Platform as an internal user, that user's password is changed.

Only a user with the login name of PlatformAdmin and with PlatformAdminRole privileges can universally administer all dashboards. So if the platform_admin user is disabled and you create a user with restoreAccess, you should create a user with a login of platform_admin.

Improper configuration of NTLMv2 authentication

If you implement NTLMv2 authentication with improper configuration and can no longer log in, use restoreAccess to restore the ability to log in.

When you run restoreAccess in this way, the utility changes the value of the Platform | Security | Login method property to Marketing Platform. This change allows you to log in with any user account that existed before you were locked out. You can optionally specify a new login name and password as well. You must restart the web application server on which Marketing Platform is deployed if you use the restoreAccess utility in this way.

Password considerations

Note the following about passwords when you use restoreAccess.

- The restoreAccess utility does not support blank passwords, and does not enforce password rules.
- If you specify a user name that is in use, the utility resets the password for that user.

Syntax

```
restoreAccess -u loginName -p password
restoreAccess -r
```

Commands

-r

When used without the -u *loginName* option, reset the value of the Platform | Security | Login method property to Marketing Platform. Requires restart of the web application server to take effect.

When used with the -u loginName option, create a PlatformAdminRole user.

Options

-u loginNname

Create a user with PlatformAdminRole privileges with the specified login name. Must be used with the -p option.

-p password

Specify the password for the user being created. Required with -u.

Examples

• Create a user with PlatformAdminRole privileges. The login name is tempUser and the password is tempPassword.

restoreAccess -u tempUser -p tempPassword

Change the value of the login method to IBM Marketing Platform and create a
user with PlatformAdminRole privileges. The login name is tempUser and the
password is tempPassword.

restoreAccess -r -u tempUser -p tempPassword

scheduler_console_client

Jobs configured in the IBM Marketing Software Scheduler can be listed and kicked off by this utility, if they are set up to listen for a trigger.

What to do if SSL is enabled

When the Marketing Platform web application is configured to use SSL, the JVM used by the scheduler_console_client utility must use the same SSL certificate that is used by the web application server on which the Marketing Platform is deployed.

Take the following steps to import the SSL certificate

- Determine the location of the JRE used by the scheduler_console_client.
 - If JAVA_HOME is set as a system environment variable, the JRE it points to is the one used by the scheduler_console_client utility.
 - If JAVA_HOME is not set as a system environment variable, the scheduler_console_client utility uses the JRE set either in the setenv script located in the tools/bin directory of your Marketing Platform installation, or on the command line.
- Import the SSL certificate used by the web application server on which the Marketing Platform is deployed to the JRE used by scheduler_console_client. The Sun JDK includes a program called keytool that you can use to import the certificate. Consult the Java documentation for complete details on using this program, or access the help by entering -help when you run the program.
- Open the tools/bin/schedulerconsoleclient file in a text editor and add the following properties. These differ depending on the web application server on which Marketing Platform is deployed.
 - For WebSphere, add these properties to the file.
 - -Djavax.net.ssl.keyStoreType=JKS
 - -Djavax.net.ssl.keyStore="Path to your key store JKS file"
 - -Djavax.net.ssl.keyStorePassword="Your key store password"
 - -Djavax.net.ssl.trustStore="Path to your trust store JKS file"
 - -Djavax.net.ssl.trustStorePassword="Your trust store password"
 - -DisUseIBMSSLSocketFactory=false
 - For WebLogic, add these properties to the file.
 - -Djavax.net.ssl.keyStoreType="JKS"
 - -Djavax.net.ssl.trustStore="Path to your trust store JKS file"
 - -Djavax.net.ssl.trustStorePassword="Your trust store password"

If the certificates do not match, the Marketing Platform log file contains an error such as the following.

Caused by: sun.security.provider.certpath.SunCertPathBuilderException: unable to find valid certification path to requested target

Prerequisites

The Marketing Platform must be installed, deployed, and running.

Syntax 3 4 1

```
scheduler_console_client -v -t trigger_name user_name
scheduler_console_client -s -t trigger_name user_name
```

Commands

-v

List the scheduler jobs configured to listen for the specified trigger.

Must be used with the -t option.

-s

Send the specified trigger.

Must be used with the -t option.

Options

```
-t trigger_name
```

The name of the trigger, as configured in the scheduler.

Example

- List jobs configured to listen for a trigger named trigger1.
 scheduler_console_client -v -t trigger1 myLogin
- Execute jobs configured to listen for a trigger named trigger1. scheduler_console_client -s -t trigger1 myLogin

eMessage Response and Contact Tracker (RCT) script

Use this script to run and check the status of the Response and Contact Tracker (RCT).

This script is located in the bin directory under your eMessage installation. The eMessage directory is a sub-directory in the Campaign directory.

In UNIX or Linux environments run the script as rct.sh.

In Windows, run the script from the command line as rct.bat.

Syntax

```
rct [ start | stop | check ]
```

Commands

start

Start the RCT

stop

Stop the RCT

Options

check

Check the status of the connection between the RCT and IBM Marketing Software Hosted Services.

Examples

To start the RCT on Windows.

```
rct.bat start
```

• To stop the RCT on Windows.

```
rct.bat stop
```

• In a Linux environment, to determine if the RCT is connected to IBM Marketing Software Hosted Services.

Depending on the status of your system, the output of this command might look like this:

```
C:\<IMS HOME>\Campaign\eMessage\bin>rct check
Testing config and connectivity for partition partition1
Succeeded | Partition: partition1 - Hosted Services Account ID:
asm admin
```

The MKService_rct script

The MKService_rct script adds or removes the Response and Contact Tracker (RCT) as a service. Adding the RCT as a service restarts the RCT every time you restart the computer where you have installed the RCT. Removing the RCT as a service prevents the RCT from restarting automatically.

This script is located in the bin directory under your eMessage installation.

In UNIX or Linux environments run MKService_rct.sh. with a user that has root permissions or permissions to create daemon processes.

In Windows, run the script from the command line as MKService rct.bat.

Syntax

```
MKService rct -install
```

MKService rct -remove

Commands

-install

Add the RCT as a service

-remove

Remove the RCT service

Examples

- To add the RCT as a Windows service. MKService_rct.bat -install
- To remove the RCT service on UNIX or Linux. MKService_rct.sh -remove

Chapter 11. Uninstalling Campaign

Run the Campaign uninstaller to uninstall Campaign. When you run the Campaign uninstaller, the files that were created during the installation process are removed. For example, files such as configuration files, installer registry information, and user data are removed from the computer.

When you install IBM Marketing Software products, an uninstaller is included in the Uninstall_Product directory, where Product is the name of your IBM product. On Windows, an entry is also added to the **Add or Remove Programs** list in the Control Panel.

If you manually remove the files in your installation directory instead of running the uninstaller, the result might be an incomplete installation if you later reinstall an IBM product in the same location. After uninstalling a product, its database is not removed. The uninstaller only removes default files that are created during installation. Any file that is created or generated after installation is not removed.

Note: On UNIX, the same user account that installed Campaign must run the uninstaller.

- 1. If you have deployed the Campaign web application, undeploy the web application from WebSphere or WebLogic.
- 2. Stop the Campaign listener.
- 3. Shut down WebSphere or WebLogic.
- 4. Stop the processes that are related to Campaign.
- 5. If the ddl directory exists in the product installation directory, run the scripts that are provided in the ddl directory to drop tables from the system table database.
- 6. Complete one of the following steps to uninstall Campaign:
 - Click the Campaign uninstaller that exists in the Uninstall_Product directory. The uninstaller runs in the mode in which you installed Campaign.
 - In a command-line window, navigate to the directory where the uninstaller exists, and run the following command to uninstall Campaign by using the console mode:

Uninstall Product -i console

• In a command-line window, navigate to the directory where the uninstaller exists, and run the following command to uninstall Campaign by using the silent mode:

Uninstall_Product -i silent

When you uninstall Campaign by using the silent mode, the uninstallation process does not present any dialogs for user interaction.

Note: If you do not specify an option for uninstalling Campaign, the Campaign uninstaller runs in the mode in which Campaign is installed.

Chapter 12. IBM Campaign web application clustering

You can configure the IBM Campaign web application (J2EE application) in a cluster by completing additional tasks during the IBM Campaign installation.

You can integrate a Campaign clustered web application environment with Interact, Distributed Marketing, Marketing Operations and eMessage.

Overview

The Campaign web application server components support load balancing when the web application is deployed in a clustered environment.

In Campaign, certain objects, such as offers, are cached in the web application server to improve response times in the user interface. In a load balanced environment, offers created on one web application server are available to users whose sessions connect through another server if you have configured campaign ehcache.xml.

The objects that are cached include: offers, offer templates and attributes, campaigns, sessions, folders, attributes, initiatives, and segments.

A clustered configuration can be used to minimize disruptions in application availability in the event of a web application server failure. Because the Campaign system tables are stored in an external database, it is not necessary to replicate data to the standby server. If the primary web application server fails, the Campaign web application must be started on the standby server. When started, the Campaign web application retrieves all current data from the Campaign system table database.

Main steps

To install IBM Campaign in a clustered web application environment, follow the instructions from chapters 2 through 8 and supplement those instructions with information from this chapter.

When you install IBM Campaign in a cluster, there are many ways to configure the installation. The following steps describe the basic process:

- 1. Run the installers on one system, typically, the administration server or whatever the equivalent is for your application server type.
- 2. Create and share a file directory to hold the upload files for all of the IBM Campaign installations.
- 3. Create the EAR or WAR file and deploy it on the cluster and web server.
- 4. Configure each system to share the IBM Marketing Platform system tables and the IBM Campaign system tables.
- 5. Configure each system to use the shared file directory.
- 6. Determine which server in the cluster will send notifications. Then, suppress the notification process on all of the other servers.
- 7. Configure campaign_ehcache.xml for distributed caching of templates and offer folders, as explained in the *IBM Campaign Installation Guide*.. To specify how often the cache is refreshed, you can adjust the Campaign cache configuration

settings, such as offerTemplateDataTTLSeconds. However, this adjustment can adversely affect performance because smaller values result in more frequent cache updates. Configuration settings are described in the *IBM Campaign Administrator's Guide*.

Note: If you have problems after deploying IBM Campaign in a cluster, copy the file commons-lang.jar to the directory /data/webservers/IBM/WAS85ND/lib/ext.

WebSphere clustering guidelines

If you are installing IBM Campaign on a cluster in WebSphere, complete these extra steps in addition to the steps for installing IBM Campaign on WebSphere.

Preparing the data sources

In addition to any other instructions provided in this guide, complete the following tasks for your data sources:

- The IBM Campaign database must be on a server that is accessible to all servers in the cluster, but it does not need to be on a server in the cluster.
- When you configure the JDBC provider, specify the cluster as the scope.

Installing the products

When you run the installer, be sure that you install Marketing Platform and IBM Campaign only once, on a server that is designated as the administration server for the cluster. The administration server is accessible to all servers in the IBM Campaign cluster.

You do not need to install the software on each cluster member. Instead, you install it on the administration server, create the EAR or WAR file, and then deploy the EAR or WAR file on each cluster member.

Note: The IBM WebSphere application server that is bundled with Campaign does not support clustering. In a clustered environment, use IBM WebSphere Application Server Network Deployment.

Pre-deployment steps

Before you deploy IBM Campaign, complete the following task:

• Share the top-level directory in which IBM Campaign is installed. For example, if you installed Campaign in C:\CampaignCluster\IBM_IMS\Campaign, you would share the entire CampaignCluster directory.

Deployment steps

In addition to the instructions in the deployment chapter (Chapter 6, "Deploying the Campaign web application," on page 57), complete the following tasks:

- 1. Map modules to servers. When you set the options in the **Select Installation Options** wizard for WebSphere, select the cluster and the web server when mapping modules to servers.
- 2. Extra instructions for the Generic JVM property: Configure the Generic JVM property on each server in the cluster.
 - The path that you specify in the <CAMPAIGN_HOME> and other properties must point to the shared installation directory.

Set the following extra parameters for clusters:

• Set the following parameter to ensure that eMessage ETL is not triggered by all clustered nodes:

-Dcampaign.emsgetl.disabled=true

For the one node that should trigger ETL eMessage data for all other nodes, set the parameter to **false**.

• Set the following parameter to ensure that Interact ETL is not triggered by all clustered nodes:

-Dcampaign.interactetl.disabled=true

For the one node that should trigger ETL Interact data for all other nodes, set the parameter to false.

Post-deployment steps

If you are using a plug-in for load balancing, complete the following configuration steps:

 For IBM Campaign to work effectively in a clustered environment, users must remain on a single node for their entire session. This option for session management and load balancing is known as session affinity. The documentation for your application server provides details about configuring your installation to use session affinity.

Note: When a node fails on a system that uses this configuration option, every user session on that node also fails. The load balancer must not switch users to another available node because user authentication applies only to a single node in IBM Campaign. Users are prompted to log in again. In some cases, an unexpected error and corresponding data loss can occur.

• Log in to IBM Campaign. Select **Settings** > **Configuration**, and configure the following URL parameters so that all references to the IBM Campaign server use the proxy host and port:

Campaign | navigation | serverURL

Configure ehcache

The ehcache is an open source Java distributed cache for caching, Java EE, and light-weight containers. Every node in the cluster can use the same campaign_ehcache.xml file or you can set a different campaign_ehcache.xml file for each node. For installations in a cluster, edit the campaign_ehcache.xml file so you do not have to restart the computer if you change any templates or offer folders.


Important:

- If your installation is upgraded from a previous version, the campaign_ehcache.xml file is overwritten. Add and edit the following sections in the file.
- You must also configure caching for user sessions (userSessionCache).

Use one of the following procedures to configure the ehcache file.

Configuring ehcache with Remote Method Invocation (RMI)

IBM Campaign systems that have the following topography typically use RMI:



Go to the <IBM_IMS_HOME>\<CAMPAIGN_HOME>\conf directory and open the campaign_ehcache.xml file in a text editor. Then, make the following edits:

You must customize the settings for machineA and machineB to reflect your environment. Provide a pipe-separated list of all servers in the cluster and use fully qualified host names.



Chapter 13. Installing a clustered listener environment

Follow these instructions if you want to install a clustered listener configuration. A listener cluster is a set of two or more listeners that act as a unit to provide load balancing and high availability. IBM Campaign listener clusters are Active-Active; meaning each node serves requests using the load-balanced approach. Each Campaign listener provides an interface between front-end clients (such as the Campaign web application) and back-end analytical server processes.

- 1. Confirm that you have met the prerequisites listed separately in "Supported listener clustering configurations" on page 116. For example, it is important that a shared file location is already configured and that you have prepared separate machines for each node in the cluster.
- 2. Follow the instructions below to install a clustered listener configuration.

Step	Description
A. Start the installer.	Go to the folder where you saved the IBM Marketing Software installer and run the installer. This invokes all of the product installers that are in that location (Marketing Platform, Campaign).
B. Install Marketing Platform if necessary.	If you have not already done so, complete the screens that install Platform, and click Done on the Installation Complete window. If you need help, see Chapter 4, "Installing Campaign," on page 41.

Step	Description			
C. Install IBM Campaign in a clustered listener configuration, optionally including the first listener.	The IBM Campaign installer opens. In this installer, you must configure IBM Campaign for a clustered configuration and, optionally, install the first listener in the cluster as well. One listener in the cluster may be installed on the Campaign web application server; however, each subsequent listener must be installed on its own standalone server. To install Campaign in a clustered listener configuration, complete the following screens:

	Continue with the process of deploying and running Campaign in your web application server, and running the listener on the Campaign server, as described in Chapter 5, "Configuring Campaign before deployment," on page 51.

E. Install the second node in the cluster. Important: Each listener node must be installed on a separate machine.	If you have not already done so, copy the IBM Marketing Software master installer and the Campaign installation files onto the server where your next Campaign installer node will run, and launch the master installer. Complete the screens as described here:			
	• In the master installer, provide the information necessary to connect to the Marketing Platform database, exactly the same way as for the first listener you installed. Each listener in the same cluster must use the same master installer configuration.

This location is known as the campaignSharedHome. Note: The value that you enter here must be the same for every listener in the cluster. 			
	 Listener Node Properties. For each node that you install in a cluster, you must specify properties such as a unique name for the node, the node's network host and port, and so on. 			
	 Master Listener Priority. The priority determines which node in the listener cluster is the master listener, and which node to use in the event of failover. 			
	 Load Balancing Weight. The weight determines how much listener traffic the node can support for sharing the processing with the other nodes. Specify any value other than zero, because a value of zero prevents the node from handling any listener connections. 			
	From this point in the installation process, the remaining screens are essentially the same as for a single-node install. When you complete the Pre-installation Summary screen, click Install to complete the installation of Campaign and the first listener node in the cluster.			
	The Campaign installer runs with the options that you specified.			
F. Restart the web app server and listeners.	When the installation is complete, restart the web application server and then start all listeners which are installed.			

Step	Description		
G. Install each subsequent node in the cluster.	Repeat the installation steps that you performed for the second listener node for each additional node you want to install. Remember that each node must be installed on a separate system from the other nodes. Restart the web application server and the listener on each node as you complete its installation.		
H. Optionally, adjust configuration settings.	Log in to Campaign to view or modify any of the configuration settings. See the <i>IBM Campaign Administrator's Guide</i> for instructions.		

You have now installed the Campaign clustered listeners.

Supported listener clustering configurations

This topic pertains to a clustered listener configuration.

Prerequisites and requirements for IBM Campaign listener cluster configurations:

- There can be only one listener per physical host machine.
- All back-end machines for clustered listeners must be running the same operating system type.
- All back-end machines for clustered listeners must have the same version of IBM Campaign installed.
- The shared network location (campaignSharedHome) must be in place and must be accessible from each physical host machine on which you plan to install a listener node. You must set this up prior to installing the listener nodes.

Diagram of listener clustering


This diagram illustrates a three-node listener cluster configuration.

Note: The following summary provides a high-level overview of the components. Details are provided in separate topics.

A cluster consists of multiple listener nodes. Each node (unica_aclsnr) is on a separate physical machine, and each node has a native ODBC connection to the Campaign system database. As with a single-node configuration, each unica_aclsnr process spawns additional back-end processes for logins and flowcharts.

Each node also has a connection to a back-end user database (not shown in diagram).

In a clustered configuration, one node acts as the master listener. The job of the master listener is to perform load balancing by distributing incoming requests to each node. The Campaign web application sends client requests over TCP/IP, and the load balancer component communicates with clustered nodes over TCP/IP. All of the nodes share a network file system, so they can access shared files. Additionally, each node has its own local tmp folder and its own set of files that are not shared.



Shared network location for clustered listeners: campaignSharedHome

A clustered listener configuration for IBM Campaign requires that certain files and folders must be shared and accessible to all of the listeners in a cluster. Therefore, you must have a shared file system in place.

Requirements

- The common area can be a machine or location that is accessible from all of the other machines in the listener cluster.
- Each listener in a cluster must have full access to the shared files and folders.
- Best practice is for all of the listeners to be on the same network, and for the shared home to also be on that network, to avoid latency issues.
- To avoid any single point of failure, the shared file system should use mirrored RAID or an equivalent method of redundancy.
- If you are installing a single-listener configuration, a shared file system is a best practice, in case you decide to implement listener clusters in the future.

Shared files and folders

In a clustered configuration, all of the listeners share the folder structure shown below. The shared location (*<campaignSharedHome>*) is specified at installation time and is configurable at **Campaign | campaignClustering | campaignSharedHome**. The shared partition contains all of the logs, campaigns, templates, and other files.

Files and folders that are not shared

Each IBM Campaign listener has its set of folders and files that are not shared, under *<Campaign_home>*. Campaign_home is an environment variable that represents the IBM Campaign application installation directory. This variable is set in cmpServer.bat (Windows) or rc.unica_ac.sh (UNIX). Partitions are specific to the local listener. Each local partition folder contains a tmp folder for temporary files during flowchart runs and a conf folder for the table manager cache file.
