Chapter 1. Release Notes for version 12.1.1

Contains information about new features, defect fixes, and known issues in Unica Plan that HCL releases as part of a scheduled software release.

System requirements and compatibility

Unica Plan operates as part of the Unica suite of products.

- Unica Plan version 12.1.1 requires Unica Platform 12.1.1.
- For reporting, Unica Plan 12.1.1 uses the 12.1.1 version of the Unica Plan and the Unica Plan Campaign reports package.

For installation instructions, see the Unica Plan Installation Guide.

Upgrade paths

Unica Plan supports the following upgrade paths:

- $12.1.x \rightarrow 12.1.1$
- $12.1.0.x \rightarrow 12.1.1$

Customers on versions earlier than 8.6.x must:

- perform a Fast Upgrade from existing version to version 8.6.0 (for more information, see *HCL Unica 8.6.0 Fast Upgrade Guide*).
- perform a Fast Upgrade from version 8.6.0 to version 12.1.0 (for more information, see *HCL Unica 12.1.0 Fast Upgrade Guide*).
- perform an in-place upgrade from version 12.1.0 to version 12.1.1.

Customers on versions earlier than 11.1.x.x can:

- perform a Fast Upgrade from existing version to version 12.1.0 (for more information, see *HCL Unica 12.1.0 Fast Upgrade Guide*).
- perform an in-place upgrade from version 12.1.0 to version 12.1.1.

Customers on versions 11.1.x.x/12.0.x.x can use one of the following options for upgrade:

Option 1

- perform an in-place upgrade from existing version to version 12.1.0.
- perform an in-place upgrade from version 12.1.0 to version 12.1.1.

• Option 2

- perform a Fast Upgrade from existing version to version 12.1.0 (for more information, see HCL Unica 12.1.0 Fast Upgrade Guide).
- perform an in-place upgrade from version 12.1.0 to verison 12.1.1.

New features and changes in version 12.1.1

Unica Plan 12.1.1 includes the following new features.

Marketing Object Default Report Type parameter

Introduced a new parameter, Marketing Object Default Report Type, in umoConfiguration to set default report type for custom marketing objects including offers.

Auto wrap parameter

Introduced a new parameter, Auto wrap, in **umoConfiguration** >> **listingPages**. This feature enables display of long names, without truncation, instead of displaying ellipsis at the end. It is applicable to Project name, Task name, Approval name, Offer name, and Offer list name. The long name is wrapped and shown in the next line of the same row.

By default Auto wrap is set to FALSE. After setting the value of Auto wrap to TRUE, restart Platform and Plan application to activate the configuration.

Search and sort in importing workflow templates

Introduced the search feature in Import and save workflow feature and also introduced sorting on Name, Created date, and Last modified date fields.

Migrate offer/offer list history

Introduced an option to migrate offer history or offer list history to Centralized Offer Management. The history records eligible for migration must meet the following criteria:

- For offers or offerlists, which are in published state, the entire history is migrated.
- For offers or offerlists, which are in retired state, the entire history is migrated.
- For offers or offerlists, which are in draft state (either new or redrafted), all the history records till the most recent published event are migrated.

Insights support of OneDB database for Plan

Introduced Unica Insights support of OneDB database for Unica Plan.

Fixed defects

HMA-325968	In case of CDW Approval, status dropdown was disabled for users other than owner and approver.	
HMA-325786	Sticky sorting issue was observed in task listing pages.	
HMA-325674	Even if the required approvers were selected for a case, the approval resubmission dialog appeared requesting you to select the required approvers.	
HMA-325665	Date and time formatting was incorrect for certain locales.	
HMA-325642	Task list sorting lost when Completing Task or if open Task in dialog.

HMA-320578	The Forecast by project type report was displaying the budget amount but not displaying the correct forecast amount.	
HMA-320354	In the My task summary report, some sections like Due to start today, and Due to finish today were not displaying any data.	
HMA-320353	In the Manager task summary report, few sections were not displaying display data.	
HMA-320352	In My approval summary report, few sections did not display data.	
HMA-320351	In Manager Approval summary, few sections were not working as expected.

HMA-320227	The vendor name and other fields were not displayed correctly in the Detailed expense breakout report.
HMA-320221	For Program budget summary by quarter, selecting 2022 as the financial year displayed the filter as 2020 in the report.
HMA-320169	In the Project ontime analysis report, the project name was displayed twice in the drill down report.
HMA-320168	For the Project health(Trend) table, duplicate columns were displayed in the table.
HMA-320086	For Projects requested and completed, the Jobs completed count was incorrect.
HMA-320085	Unica Content Integration had a UI issue for lengthy file names.
HMA-319755	Selection of checklist, using the dropdown menu, was possible even if the user has only view permission.
HMA-319130	In case of the Internet Explorer browser, user had to click twice, in the first attempt, to select and share with users from the list.

This scenario occurs because the buttons on the right pane are driven by the role of the user: Approver or Approval owner. Formulas for computing metrics must be in English	DEF057660	When adding metrics to metrics templates, the user can specify them as Planned or Rollup . If the user enters a formula in the Computed by Formula field, the formula must be in English. An error results if a user enters a translated string instead of ROLLUP.

HMA-330133	In some cases, clicking Save for later throws an error and does not save the approval.
HMA-330116	Selecting the approver, under the pre-assigned role, displays two steps in the approval steps.
HMA-330115	Deleting approvers, from the selected steps, does not unblock the users from selection after the steps are deleted.
HMA-329839	In Unica Insights Reports, todays date is not mentioned at the bottom of the excel exported file type.
HMA-329470	For OneDB, by default, the dbtype in umoconfiguration of Plan shows all five values. We must manually edit it and set it to OneDB.

HMA-283675	When URL value is used in a single select attribute value, all attribute values display.
HMA-283523	When an OOO user tries to assign the task to himself, delegation fails.
Defect 272141	If you use the required attributes feature in versions before 10.1 and have upgraded to version 12.0, the rules for required features are not retained in version 12.0. To make an attribute required, you must edit the attribute and select the Required option for the attribute. However, this makes the attribute a required attribute on all the forms that it is included in.
	This issue does not occur if you upgrade from version 10.1 or newer version.
N/A	When integrated with Tivoli Access Manager, under select circumstances, an "Incomplete Reply from server" error might occur when performing certain actions in the application (for example, configuring form attributes).
N/A	REST API support is not available for all APIs. To see supported APIs in V12, see the Unica Plan REST APIs documentation.
N/A	The systems that use DB2 v10.1, the NOT EXISTS operator produces duplicate results. Results can be incorrect for queries that include a NOT EXISTS clause.

HMA-303714	When the rich text is at screen bottom and users need to scroll down the screen to reach it, use of tools of Rich Text makes the scroll to back to the top of the screen.
	When the rich text field has a scrollbar and a table is inserted at the bottom of this field, the user needs to scroll the field to see the contextual menu of table when they selects a cell.
HMA-176872, HMA-176873	During installation, uppercase database credentials cause errors. Workaround: Enter database details for the host name and domain name in lower case characters.
N/A	In a Safari browser, when you click Download Original in the markup window, the file is saved successfully on disk. However, it opens a blank tab window along with every download. This is a Safari browser issue.
	To avoid this issue you can try to hold the Option key and click Download Original to download without opening new blank tab. You can also right click Download Original to open a context pop-up menu. Click Save Image As to save the file to the desired location. It does not open a new tab.
